### Activities, Officers, and Council During 2016-2017

Karen A. Gould has served as executive director since January 1, 2008.

Michael W. Robinson of Tysons Corner served as president of the bar from June 18, 2016, until June 17, 2017. President Robinson's leadership as president of the Virginia State Bar was exemplified by his unwavering commitment to improving the profession and to protecting and informing the public, by supporting the staff of the Virginia State Bar in a myriad of ways, including its budget discussions, his insightful analysis of difficult constitutional issues and assisting during the legislative effort to amend Va. Code § 54.1-3935. He provided wise leadership and direction at Executive Committee and Bar Council meetings, for example, the Council debate on mandatory pro bono reporting was a debate conducted under his leadership that was orderly, thoughtful, did not extend beyond reasonable time parameters, and yet there was never an issue of whether Council members had the opportunity to hear the ideas and concerns of a broad group of engaged members.

Doris Henderson Causey became president of the VSB at the conclusion of the 2017 Annual Meeting.

Ms. Causey served ex-officio on the VSB Executive Committee during 2016-2017 as president-elect. Ed Weiner served ex-officio as immediate past president. Marni E. Byrum, Nancy C. Dickenson, and Leonard C. Heath, Jr. continued to serve on the Executive Committee during the 2016-2017 bar year. William E. Glover, Eugene M. Elliott, Jr. and Todd A. Pilot were elected by the council as new members of the 2016-17 executive committee, replacing Michael HuYoung, Brian L. Buniva and Daniel L. Rosenthal. Barbara S. Anderson, Latoya Asia Capers, and Bruce E. Robinson, the new chairs of the Conference of Local Bar Associations, the Diversity Conference, and the Senior Lawyers Conference, respectively, and Dean E. Lhospital, the incoming president of the Young Lawyers Conference, completed the 2016-17 roster of the executive committee.

In summary, council consists of the three officers, four conference chairs, nine at-large members appointed by the Supreme Court of Virginia, and sixty-five elected members.

### Highlights from the FY2016-2017 Council Meetings

### 1.October 7, 2016 Meeting

This meeting took place during a torrential downpour in Roanoke, Virginia, while a hurricane bore down on Virginia Beach. Attendance was reduced as a result of the weather conditions. (a) Only 54 of the 81 eligible Council members were present and voted during the first action item, which dealt with whether to adopt mandatory reporting of pro bono hours. After a vigorous two-hour debate, the proposal was rejected 29-25. (b) Council unanimously approved the proposed amendments to Paragraph 13-24 of Part 6, Section IV of the Rules of the Supreme Court of Virginia dealing with reciprocal discipline, which went on to be approved by the Supreme Court of Virginia, effective March 1, 2017, https://www.vsb.org/docs/SCV para 13-24 121516.pdf. (c) Council also unanimously approved proposed amendments to Va. Code Va. Code § 54.1-3935 and authorized the Virginia State Bar to seek the legislative changes, subject to the approval of the Supreme Court of Virginia. The Court subsequently approved the changes. The legislative changes proposed made their way in HB1479. The revisions to § 54.1-3935, patroned as identical bills in both houses of the General Assembly, HB 1479 by Delegate James A. Leftwich and SB 874 by Senator Thomas K. Norment, unanimously passed both houses and were approved by Governor McAuliffe on February 17, 2017. The changes become effective July 1, 2017. (d) In addition to these action items, Council approved changes to Paragraph 13.1, permitting the executive director to take action on professional course extension requests in between meetings of the executive committee. The changes to Paragraph 13.1 were approved by the Supreme Court and became effective March 1, 2017, https://www.vsb.org/docs/SCV para 13.1 121516.pdf. (e) LEO 1866 was approved by Council and was subsequently approved by the Supreme Court of Virginia on December 15, 2016, effective immediately, https://www.vsb.org/docs/SCV\_para\_13.1\_121516.pdf. LEO 1886 covers the ethical duty of partners and supervisory lawyers in a law firm when another lawyer in the firm suffers from significant impairment.

### 2. February 25, 2017 Meeting

(a) Council unanimously approved revisions to the Clients' Protection Fund Rules, which combined two sets of rules previously governing operation of the Fund. The amendments outline the purpose, funding, authority, and administration of the CPF. The amendments also improve the structure and organization of the rules of procedure that outline the administration of the CPF, including the procedure for processing claims. The purpose of the amendments is to clarify the authority for the

CPF as well as to facilitate understanding of the CPF for both VSB members and the public, <a href="https://www.vsb.org/pro-guidelines/index.php/cpf-rules">https://www.vsb.org/pro-guidelines/index.php/cpf-rules</a> (b) Council also voted 65-1 to send proposed amendments to Rules of Professional Conduct 7.1 to 7.5 (the advertising rules) to the Supreme Court of Virginia for approval. The amendments simplify and modernize the lawyer advertising rules in light of changes caused by the rise of Internet marketing and communications. The Supreme Court approved the advertising rule changes as submitted, effective July 1, 2017, <a href="https://www.vsb.org/docs/SCV">https://www.vsb.org/docs/SCV</a> order para 7 1 7 5.pdf.

#### 3. June 15, 2017 Meeting

(a) Council approved a \$ 14.9 million budget for FY2017-18. This is a decrease of \$10,000 from the 2016-17 operating budget. The budget includes a 3 percent raise for VSB employees as authorized by the General Assembly. The Standing Committee on Budget & Finance recommended in this budget that executive committee meetings not associated with council meetings be held in Richmond so that they could be cancelled without any cancellation fees being assessed. The budget was sent to the Supreme Court of Virginia for consideration at its August business meeting. The Court had provisionally approved the budget until it could be reviewed at that meeting. (b) Council approved amendments to the VSB Social Media Policy; and (c) Council approved proposed LEO 1887, which deals with the situation presented by a sole partner in a firm or solo lawyer who is impaired and what duty is owed by an attorney who has knowledge of this impairment. A petition asking for approval of LEO 1887 has been sent to the Supreme Court of Virginia.

### 2017 Annual Meeting

The VSB 2017 Annual Meeting was hosted for the third time at three hotels: the Holiday Inn & Suites North Beach; the Sheraton Virginia Beach Oceanfront Hotel; and the Hilton Virginia Beach Oceanfront. Room blocks were arranged at those three hotels, in addition to five additional hotels in an eight-block radius. An online app was available to download and was helpful in orienting members to their meetings' locations. The 2017 meeting went very well, with few complaints.

#### **Judicial Candidate Evaluation Committee Evaluations**

The JCEC did not interview or evaluate candidates in FY2016-2017.

### FY2016 Audit Report

The audit report for FY2016, was being conducted but had not been not finalized as of June 30, 2017.

### **Clients' Protection Fund**

The Clients' Protection Fund was established in 1976 to make monetary awards to persons who suffered financial losses due to the dishonest conduct of Virginia lawyers. The total amount paid during FY2016-2017 was \$343,428.86 for 50 claims. Fourteen petitions were denied, and thirteen petitions were rejected for not meeting the CPF rule requirements. The fund balance as of June 30, 2017, was \$8,911,684. The CPF assessment paid by active VSB members raised \$805,600 in FY2016-2017.

### **Enterprise Client Management Project**

During FY2016-2017, the ECRM project continued with the implementation of ECRM in several departments including MCLE, VLRS, and Access to Legal Services. Software upgrades along with a new development and testing environment were completed and put into production. At this point the ECRM implementation project is nearing completion with almost all major departments running under our new document management system. The remaining departmental implementations include Bar Services and Fiscal, which have been delayed until the coming FY2017-2018 fiscal year due to scheduling conflicts and personnel changes. Moving forward, any new ECRM implementations and updating will be completed by VSB staff with the IQ Consulting firm being used only on a time and materials contingency basis.

ALPS has been the VSB's endorsed lawyers' professional liability carrier since October 2000. ALPS became an admitted carrier in Virginia on February 1, 2015. ALPS is now subject to SCC regulation and in the event of insolvency, ALPS insureds would have access to the Virginia Guarantee Fund. The VSB Special Committee on Lawyer Malpractice Insurance continued its work during FY2016-2017 in implementation of the 3% risk management fund created from gross written premium as part of the ALPS endorsement agreement permitted by statute. This fund is maintained and utilized by ALPS as agreed by the committee and the ALPS management team in CLE programs held throughout Virginia. ### **Regulatory Changes**

Changes to the Rules of Professional Conduct

Rules of Professional Conduct 7.1-7.5 as amended by the Supreme Court of Virginia, effective July 1, 2017:

#### INFORMATION ABOUT LEGAL SERVICES.

### RULE 7.1. Communications Concerning A Lawyer's Services.

A lawyer shall not make a false or misleading communication about the lawyer or the lawyer's services. A communication is false or misleading if it contains a material misrepresentation of fact or law, or omits a fact necessary to make the statement considered as a whole not materially misleading.

#### Comment

- [1] Truthful statements that are misleading are also prohibited by this Rule. A truthful statement is misleading if it omits a fact necessary to make the lawyer's communication considered as a whole not materially misleading. A truthful statement is also misleading if there is a substantial likelihood that it will lead a reasonable person to formulate a specific conclusion about the lawyer or the lawyer's services for which there is no reasonable factual foundation.
- [2] A communication that truthfully reports a lawyer's achievements on behalf of clients or former clients may be misleading if presented so as to lead a reasonable person to form an unjustified expectation that the same results could be obtained for other clients in similar matters without reference to the specific factual and legal circumstances of each client's case. Similarly, an unsubstantiated comparison of the lawyer's services or fees with the services or fees of other lawyers may be misleading if presented with such specificity as would lead a reasonable person to conclude that the comparison can be substantiated. The inclusion of an appropriate disclaimer or qualifying language may preclude a finding that a statement is likely to create unjustified expectations or otherwise mislead the public.
- [3] In communications about a lawyer's services, as in all other contexts, it is professional misconduct for a lawyer to engage in conduct involving dishonesty, fraud, deceit or misrepresentation which reflects adversely on the lawyer's fitness to practice law. Rule 8.4(c). See also Rule 8.4(d) for the prohibition against stating or implying an ability to influence improperly a government agency or official or to achieve results by means that violate the Rules of Professional Conduct or other law.

### Areas of Expertise/Specialization

[4] A lawyer may communicate the fact that the lawyer does or does not practice in particular fields of law. A lawyer who is a specialist in a particular field of law by experience, specialized training, or education, or is certified by a named professional entity, may communicate such specialty or certification so long as the statement is not false or misleading.

#### Firm Names

[5] A firm may be designated by the names of all or some of its members, by the names of deceased members where there has been a continuing succession in the firm's identity or by a trade

name such as the "ABC Legal Clinic." A lawyer or law firm may also be designated by a distinctive website address or comparable professional designation. Although the United States Supreme Court has held that legislation may prohibit the use of trade names in professional practice, use of such names in law practice is acceptable so long as it is not misleading. If a private firm uses a trade name such as "clinic" that also includes a geographical name such as "Springfield Legal Clinic," an express disclaimer that it is not a public legal aid agency may be required to avoid a misleading implication. It may be observed that any firm name including the name of a deceased partner is, strictly speaking, a trade name. The use of such names to designate law firms has proven a useful means of identification. However, it is misleading to use the name of a lawyer not associated with the firm or a predecessor of the firm, or the name of a nonlawyer.

[6] Lawyers may state or imply that they practice in a partnership or other organization only when that is the fact. Lawyers sharing office facilities, but who are not in fact associated with each other in a law firm, may not denominate themselves as, for example, "Smith and Jones," for that title suggests that they are practicing law together in a firm.

### RULE 7.2. Advertising [DELETED].

### **RULE 7.3. Solicitation of Clients.**

- (a) A solicitation is a communication initiated by or on behalf of a lawyer that is directed to a specific person known to be in need of legal services in a particular matter and that offers to provide, or can reasonably be understood as offering to provide, legal services for that matter.
- (b) A lawyer shall not solicit employment from a potential client if:
- (1) the potential client has made known to the lawyer a desire not to be solicited by the lawyer; or
- (2) the solicitation involves harassment, undue influence, coercion, duress, compulsion, intimidation, threats or unwarranted promises of benefits.
- (c) Every written, recorded or electronic solicitation from a lawyer shall conspicuously include the words "ADVERTISING MATERIAL" on the outside envelope, if any, and at the beginning and ending of any recorded or electronic solicitation, unless the recipient of the solicitation:
- (1) is a lawyer; or
- (2) has a familial, personal, or prior professional relationship with the lawyer; or
- (3) is one who has had prior contact with the lawyer; or
- (4) is contacted pursuant to court-ordered notification.
- (d) A lawyer shall not compensate, give, or promise anything of value to a person who is not an employee or lawyer in the same law firm for recommending the lawyer's services except that a lawyer may:
- (1) pay the reasonable costs of advertisements or communications permitted by this Rule and Rule 7.1, including online group advertising;
- (2) pay the usual charges of a legal service plan or a not-for-profit qualified lawyer referral service;
- (3) pay for a law practice in accordance with Rule 1.17; and
- (4) give nominal gifts of gratitude that are neither intended nor reasonably expected to be a form of compensation for recommending a lawyer's services.

#### Comment

#### Direct Contact between Lawyers and Laypersons

- [1] A lawyer's communication typically does not constitute a solicitation if it is directed to the general public, such as through a billboard, an Internet banner advertisement, a website or a television commercial, or if it is in response to a request for information or is automatically generated in response to Internet searches.
- [2] There is far less likelihood that a lawyer would engage in abusive practices against an individual who is a former client, or with whom the lawyer has a close personal or family relationship; nor is there a serious potential for abuse when the person contacted is a lawyer or when the person has already initiated contact with the lawyer. Consequently, the requirements of Rule 7.3(c) are not applicable in those situations.
- [2a] The requirement in Rule 7.3(c) that certain communications include "ADVERTISING MATERIAL" does not apply to communications sent in response to requests of potential clients or their spokespersons or sponsors; however, prior contact from the lawyer in the form of advertising material does not circumvent the need to include the words "ADVERTISING MATERIAL" in future contacts. General announcements by lawyers, including changes in personnel or office location, do not constitute communications soliciting professional employment from a potential client known to be in need of legal services within the meaning of this Rule.
- [3] Even permitted forms of solicitation can be abused; thus, any solicitation that contains information that is false or misleading within the meaning of Rule 7.1, which involves coercion, duress or harassment within the meaning of Rule 7.3(b), or which involves contact with a potential client who has made known to the lawyer a desire not to be solicited by the lawyer within the meaning of Rule 7.3(b), is prohibited. Moreover, if after sending a letter or other communication to a potential client the lawyer receives no response, continued repeated efforts to communicate with the potential client may constitute harassment and therefore violate the provisions of Rule 7.3(b). Regardless of the form of the communication, its propriety will be judged by the totality of the circumstances under which it is made, including the potential client's sophistication and physical, emotional, and mental state, the nature and characterization of the legal matter, the parties' previous relationship, the lawyer's conduct, and the words spoken.

#### Paying Others to Recommend a Lawyer

- [4] Lawyers are not permitted to pay others for recommending the lawyer's services or for channeling professional work in a manner that violates Rule 7.1 and this Rule. A communication contains a recommendation if it endorses or vouches for a lawyer's credentials, abilities, competence, character, or other professional qualities. However, Paragraph (d)(1) allows a lawyer to pay for advertising and communications permitted by this Rule, including the costs of print directory listings, on-line directory listings, newspaper ads, television and radio airtime, domain-name registrations, sponsorship fees, banner ads, and group advertising. A lawyer may compensate employees, agents, and vendors who are engaged to provide marketing or client-development services, such as publicists, public-relations personnel, business-development staff, and website designers, as long as the employees, agents, and vendors do not direct or control the lawyer's professional judgment in violation of Rule 5.4(c). See Rule 5.3 for the duties of lawyers and law firms with respect to the conduct of nonlawyers who prepare marketing materials for them. Moreover, a lawyer may pay others for generating client leads, such as internet-based client leads, as long as the lead generator does not recommend the lawyer, any payment to the lead generator is consistent with Rule 5.4, and the lead generator's communications are consistent with Rule 7.1. To comply with Rule 7.1, a lawyer must not pay a lead generator that states, implies, or creates a reasonable impression that it is recommending the lawyer, is making the referral without payment from the lawyer, or has analyzed a person's legal problems when determining which lawyer should receive the referral.
- [5] Selection of a lawyer by a layperson should be made on an informed basis. Advice and recommendation of third parties—relatives, friends, acquaintances, business associates, or other lawyers—and publicity and personal communications from lawyers may help to make this possible. A lawyer should not compensate another person for recommending him or her, for influencing a potential client to employ him or her, or to encourage future recommendations.
- [6] A lawyer may pay the usual charges of a legal service plan or a not-for-profit lawyer referral service. A legal service plan is a prepaid or group legal service plan or a similar delivery system that assists potential clients to secure legal representation. Not-for-profit lawyer referral services are consumer-oriented organizations that provide unbiased referrals to lawyers with appropriate

experience in the subject matter of the representation and afford other client protections, such as complaint procedures or malpractice insurance requirements. Consequently, this Rule permits a lawyer to pay only the usual charges of a not-for-profit lawyer referral service.

### RULE 7.4. Communication Of Fields Of Practice And Certification [DELETED].

### RULE 7.5. Lawyer and Firm Names And Letterheads [DELETED].

### Paragraph 13-24 as amended by the Supreme Court of Virginia, effective March 1, 2017:

13-24 BOARD PROCEEDINGS UPON DISBARMENT, REVOCATION OR SUSPENSION IN ANOTHER JURISDICTION

- A. <u>Definitions Specific to Paragraph 13-24</u>. The following terms shall have the meaning set forth below unless the content clearly requires otherwise:
- 1. "State Jurisdiction" means any state, United States Territory, or District of Columbia law licensing or attorney disciplinary authority, including the highest court of any such Jurisdiction, authorized to impose attorney discipline effective throughout the Jurisdiction.
- 2. "Jurisdiction" shall refer to either a "State Jurisdiction" or any federal court or agency authorized to discipline attorneys, including the United States military.
- В. Initiation of Proceedings. Upon receipt of a notice from the Clerk of the Disciplinary System that another Jurisdiction has, as a disciplinary measure, suspended or revoked the law license of an Attorney ("Respondent") or has suspended or revoked Respondent's privilege to practice law in that Jurisdiction, and that such action has become final (the "Suspension or Revocation Notice"), any Board member shall enter on behalf of the Board an order requiring Respondent to show cause why discipline that is the same or equivalent to the discipline imposed in the other Jurisdiction should not be imposed by the Board. If the Suspension or Revocation Notice is from a State Jurisdiction and the suspension or revocation has not been suspended or stayed, then the Board's order shall suspend Respondent's License pending final disposition of the Proceeding hereunder. The Board shall serve upon Respondent by certified mail the following: a copy of the Suspension or Revocation Notice; a copy of the Board's order; and a notice fixing the date, time and place of the hearing before the Board to determine what action should be taken in response to the Suspension or Revocation Notice and stating that the purpose of the hearing is to provide Respondent an opportunity to show cause why the same or equivalent discipline that was imposed in the other Jurisdiction should not be imposed by the Board. Notwithstanding the above, notice of a suspension or revocation for merely administrative reasons, such as the failure to pay dues or the failure to complete required continuing legal education, shall not be considered a Suspension or Revocation Notice.
- C. <u>Opportunity for Response</u>. Within 14 days of the date of mailing of the Board order, via certified mail, to Respondent's last address of record with the Bar, Respondent shall file with the Clerk of the Disciplinary System a written response, which shall be confined to argument and exhibits supporting one or more of the following grounds for dismissal or imposition of lesser discipline:
- 1. The record of the proceeding in the other Jurisdiction would clearly show that such proceeding was so lacking in notice or opportunity to be heard as to constitute a denial of due process;
- 2. The imposition by the Board of the same or equivalent discipline upon the same proof would result in an injustice;
- 3. The same conduct would not be grounds for disciplinary action or for the same or equivalent discipline in Virginia; or
- 4. The misconduct found in the other Jurisdiction would warrant the imposition of substantially lesser discipline in the Commonwealth of Virginia.
- D. <u>Scheduling and Continuance of Hearing</u>. Unless continued by the Board for good cause, the hearing shall be set not less than 21 nor more than 30 days after the date of the Board's order.

- E. <u>Provision of Copies</u>. The Clerk of the Disciplinary System shall furnish to the Board members designated for the hearing and make available to Respondent copies of the Suspension or Revocation Notice, the Board's order against the Respondent, the notice of hearing, any notice of continuance of the hearing, and any written response or materials filed by Respondent or by Bar Counsel.
- F. <u>Hearing Procedures</u>. Insofar as applicable, the procedures for Proceedings on allegations of Misconduct shall govern. Bar Counsel has discretion to put forth evidence and argument that one or more of the grounds specified in Paragraph 13-24.C exists. If Respondent does not file a timely written response, but appears at the hearing and expresses intent to present evidence or argument supporting the existence of one or more of the grounds specified in Paragraph 13-24.C, Respondent shall make a proffer to the Board. The Board may refuse to consider such evidence or argument as untimely. If the Board in its discretion is willing to consider such evidence or argument, then Bar Counsel, upon motion, may be entitled to a continuance.
- G. <u>Burden of Proof.</u> The burden of proof to establish the existence of one or more of the grounds specified in Paragraph 13-24.C is clear and convincing evidence. Unless one or more of the grounds specified in Paragraph 13-24.C has been established by clear and convincing evidence, the Board shall conclude that Respondent was afforded due process by the other Jurisdiction and the findings of the other Jurisdiction shall be conclusive of all matters for purposes of the Proceeding before the Board.
- H. Action by the Board. If the Board determines that none of the grounds specified in Paragraph 13-24.C exist by clear and convincing evidence, it shall impose the same or equivalent discipline as imposed in the other Jurisdiction. If the Board finds by clear and convincing evidence the existence of one or more of the grounds specified in Paragraph 13-24.C, the Board shall enter an order it deems appropriate. A copy of any order imposing discipline shall be served upon Respondent via certified mail, return receipt requested. Any such order shall be final and binding, subject only to appeal as set forth in the Rules of Court.

The amendments effective March 1, 2017, revised Paragraph 13 to clarify what qualifies as another jurisdiction for reciprocal discipline purposes; clarify the disciplinary board's authority to impose the same, equivalent, or lesser discipline as another jurisdiction; allow for leniency as appropriate; and provide the disciplinary board with discretion in enforcing the default provision.

#### Paragraph 13.1 as amended by the Supreme Court of Virginia, effective March 1, 2017:

#### 13.1 Suspension for Failure to Complete Professionalism Course—

Each person admitted to the Virginia State Bar on or after July 1, 1988, as an active member shall complete the course of study prescribed by the Executive Committee of the Virginia State Bar and approved by the Supreme Court of Virginia on the Rules of Professional Conduct and the lawyer's broader professional obligations, and any active member who fails to complete the course shall be suspended unless an extension is obtained for good cause shown. Such course of study shall be funded by attendance fees paid by those attending the course.

Any active member licensed after June 30, 1988, and any other member who changes his or her membership to active status shall complete the required course within twelve months of becoming an active member. Failure to comply with this Rule shall subject the active member to the penalties set forth in Paragraph 19 herein.

"Good cause shown" as used herein shall include illness, hospitalization or such other cause as may be determined by the Executive Committee, whose determination shall be final. The Executive Director of the Virginia State Bar is authorized to grant extensions for compliance with this paragraph until the next Executive Committee meeting. Any determination by the Executive Committee or the Executive Director may be reviewed by the Supreme Court on request of the member seeking an extension.

The amendments effective March 1, 2017, authorize the VSB executive director to grant, for good cause, an extension request from a member who fails to complete the Professionalism Course by the deadline.



# Report of the Office of Bar Counsel

### Edward L. Davis, Bar Counsel

#### I. Overview

The Office of Bar Counsel [OBC] consists of the intake and discipline departments. The intake department initially receives and screens all inquiries to the bar about attorney conduct and proactively handles inquiries alleging minor misconduct. Intake also performs preliminary investigations in a limited class of cases. The discipline department receives complaints forwarded from the intake department and conducts investigations and prosecutions of such cases before district committees, the Disciplinary Board and three-judge circuit courts. It also petitions the circuit courts for injunctions and the appointment of receivers when such relief is necessary to prevent the loss of client property by dishonest lawyers, or when needed to wind up the practices of disabled, deceased or disbarred attorneys if no other person is reasonably able to do so.

#### II. Personnel Matters

One attorney departed the OBC during the fiscal year. As discussed below in Part IV, the OBC decided not to fill this position as part of its new strategic plan.

Richmond attorney Laura Ann Booberg joined the VSB staff on August 27, 2016. She replaced Renu Brennan, who was promoted to deputy executive director in April 2016. Laura had been practicing law for 23 years with a focus on worker's compensation, social security disability and immigration law. Avid in outdoor sports, she has completed two marathons and is a member of the U.S. Tennis Association. Laura assumed responsibility for the Third District Committee, Section II, the Fourth District Committee, Section II, and part of the Fifth District Committee, Section III.

Fifteen-year, central Virginia investigator Gene Rhodenizer retired in October 2016. He was replaced by northern Virginia investigator Dave Jackson, who relocated to Orange County. Mr. Jackson in turn was replaced by former VSB Investigator Edward Bosack, effective September 12, 2016, following his return from assignment in Kuwait with the Department of Defense. Finally, Southwest Virginia Investigator Mike Keen retired in February 2017. He was replaced by Robert Baker, who joined the staff on April 3, 2017. Mr. Baker works the Eighth, Ninth and Tenth District Committees that reach from Lynchburg to the borders of Tennessee and West Virginia. Mr. Baker holds a law degree and is a retired Southern California police sergeant. He brings a wealth of experience in complex administrative and criminal investigations, as well as exceptional writing skills.

Finally, the bar's long-term Clerk of the Disciplinary System, Barbara Lanier, announced her retirement effective August 7, 2017. Barbara has been helping us with her knowledge, organization and leadership for more than two decades, having previously

served as director of the MCLE department. We will miss her greatly, and wish her all our best in a very well deserved retirement.

DaVida M. "Dee" Davis is the new Clerk of the Disciplinary System. Dee comes to us from the Circuit Court for the City of Norfolk, where she served more than 20 years as a supervising deputy clerk. Prior to Norfolk, she was a deputy clerk in the Circuit Court for the City of Richmond. She played a key role in developing the Norfolk Circuit Court's paperless program. Dee brings a wealth of knowledge in technology, organization and management to the Virginia State Bar and we all look forward to working with her.

Effective July 1, 2017, Assistant Bar Counsel Katie Uston became President of the National Organization of Bar Counsel.

### III. Production

In fiscal year 2017, there were 126 public trials, agreed dispositions and consents to revocation, an increase of 16 (14.5%) from the 110 reported one year ago. The year ended with a slight increase in the total volume of open cases, from 348 to 352, or 1.1%. Nonetheless, this constitutes a reduction of 58.6% from the 851 total open cases five years ago. The fiscal year ended with only eight "pre-016" cases. This is the lowest that this number has ever been since I began reporting it nine years ago. The new fiscal year began with 41 "pre-017" cases, down from 70 one year ago. By comparison, the number was 250 on July 1, 2008.

These reductions reflect continued increases in the processing of cases as well as the quality of attorneys and staff now at the bar. In addition, the intake staff continues to process more cases to conclusion through summary dismissals of complaints that do not affect the disciplinary rules, and the proactive resolutions of minor misconduct without creating disciplinary records.

### IV. Outlook

For the third time in the past three years, the OBC chose not to fill a position vacancy among its attorneys. The result is a reduction in the attorney staff from 13 to 10 over the past three years. The OBC also reduced its administrative support staff in recent years. The reasons for these reductions are budgetary and strategic in nature. We found that a high-caliber of attorneys and support staff have enabled the OBC to significantly reduce the overall volume of open cases, as indicated above in Part III. Further, the new managerial structure implemented last year, with Ed Dillon and Brent Saunders serving as Senior Assistant Bar Counsel, has led to more timely review and issuing of charging documents in disciplinary cases. With this reduction in staff, the OBC will keep an eye on the case dockets to ensure that it continues this trend while meeting its public protection mission.

#### V. Changes to Procedural Rules and Rules of Professional Conduct

On December 15, 2016, the Supreme Court of Virginia approved amendments to the Rules of Court, Part 6, Section IV, Paragraph 13-24, effective March 1, 2017. The rule addresses disciplinary procedures deriving from law license suspensions or revocations imposed by other jurisdictions, or reciprocal discipline. The revised rule clarifies what constitutes another jurisdiction, eliminates the automatic suspension of a lawyer's license if the other jurisdiction is not a state licensing or disciplinary authority, and removes the automatic default provisions of the previous rule. Other changes allow

respondents to present more defenses and provide the Disciplinary Board with the discretion to dismiss or impose lesser sanctions.

Also on December 15, 2016, the Supreme Court of Virginia amended and adopted, effective immediately, Legal Ethics Opinion 1886 regarding the duty of partners and supervisory lawyers in a law firm when another lawyer in the firm suffers from significant impairment.

At its 2017 session, the Virginia General Assembly approved amendments to Virginia Code Section 54.1-3935, the statute governing attorney disciplinary proceedings before three-judge circuit courts. The Governor signed the amendments into law effective July 1, 2017. The amendments clarify the procedures for a respondent attorney who wishes to have his or her disciplinary case heard by a three-judge circuit court.

On April 17, 2017, the Supreme Court approved amendments to the advertising rules (Rules 7.1-7.5 of the Rules of Professional Conduct), effective July 1, 2017. The amendments significantly simplify the regulations for lawyer advertising.

### VI. Matters in the Supreme Court of Virginia

#### A. Reinstatement Cases

On February 9, 2017, Anne Marston Lynch petitioned for the reinstatement of her law license. Ms. Lynch consented to the revocation of her license on December 3, 2009, while disciplinary charges were pending. The bar will conduct an investigation before the Disciplinary Board hears the matter.

On February 17, 2017, the Supreme Court of Virginia approved the Disciplinary Board's Recommendation Order to reinstate the law license of Catherine Ann Lee.

On November 13, 2013, the Disciplinary Board entered an Order of Recommendation to reinstate the law license of Rickey Gene Young, subject to his payment of \$13,333.33 to the Bar's Client Protection Fund within 18 months of the date of the order. The Supreme Court approved the Board's recommendation. Mr. Young, however, never reimbursed the Client Protection Fund as ordered, and his license remains revoked. In 2017, Mr. Young filed for bankruptcy in the Western District of Virginia. Among other relief, Mr. Young sought a discharge of his obligation to reimburse the Client Protection Fund. The bar, represented by Assistant Attorney General Robert McEntee, moved for summary judgment on the basis that the obligation is non-dischargeable. On August 23, 2017, the U.S. Bankruptcy Court, Danville Division, heard the motion and entered an order of summary judgment, finding that Young's financial obligations to the Virginia State Bar were not dischargeable.

### B. Appeals Decided by the Supreme Court of Virginia

On June 28, 2016, Jane Karen Eshagpoor appealed the two-year suspension of her law license imposed by the Disciplinary Board on May 23, 2016. She also filed a petition to stay the suspension pending appeal, and the bar filed a response in opposition. By order, entered July 7, 2016, the Supreme Court denied the stay. Thereafter, Ms. Eshagpoor withdrew her appeal.

On December 8, 2016, the Supreme Court of Virginia affirmed the Disciplinary Board's decision to revoke the law license of Jean Jerome Dandy Ngando Ekwalla. Respondent

filed a motion for reconsideration that the Supreme Court of Virginia denied on March 24, 2017. The Supreme Court issued its mandate, and the matter has become final.

On February 24, 2017, Dominick Anthony Pilli filed a petition to stay the year-and-a-day suspension of his law license imposed by the Disciplinary Board on February 17, 2017. On February 27, Assistant Bar Counsel Katie Uston filed an opposition, and the Supreme Court of Virginia denied Respondent's petition that afternoon. On April 4, 2017, Pilli filed a notice of appeal and assignments of error. The bar, represented by Assistant Attorney General/Chief Rita Davis, filed a motion to dismiss the appeal as untimely. In response, Mr. Pilli's counsel filed a motion to withdraw the appeal, and on June 23, 2017, the Supreme Court issued its mandate withdrawing the appeal. The matter has become final.

On March 10, 2017, the Supreme Court of Virginia dismissed Wayne Richard Hartke's appeal of the three-year suspension of his law license. This followed a motion to dismiss drafted by Assistant Bar Counsel Katie Uston and filed by Senior Assistant Attorney General/Chief Rita Davis. Mr. Hartke did not meet all of the procedural requirements, such as noting assignments of error in his notice of appeal and indicating whether he had ordered the transcript as required by the Rules of Court.

C. Appeals Pending before the Supreme Court of Virginia

# **Education of Lawyers in Virginia**

#### Membership

As of June 2017, the Education of Lawyers Section had 508 members, compared to 414 last year. The membership included 210 active members, 44 judicial members, and 160 members of the Academy.

#### **Budget**

The budget for fiscal year 2016-17 was \$9,200, which included a number of contributions from Virginia's law schools and law firms. We are redoubling our efforts to gain increased firm support in the coming year.

#### Rakes Leadership in Education Award

The 2017 recipient of the section's William R. Rakes Leadership in Education Award was James E. Moliterno, Vincent Bradford Professor of Law, Washington and Lee University School of Law. The section hosted an award presentation reception sponsored by Gentry Locke on Friday, June 16, 2017, in Virginia Beach, in conjunction with the State Bar's 79<sup>th</sup> Annual Meeting. ### Legal Writing CLE - Follow Up to the 20<sup>th</sup> Anniversary Conclave

# Litigation

Budget: \$36,000

- In conjunction with the Virginia State Bar's Communications Committee, the Litigation Section has been a cosponsor of the Law in Society Essay Contest since its inception. The section again provided financial support for the contest this past year, funding the Bar's efforts to distribute the contest hypothetical throughout the Commonwealth and also funding prizes for the contest winners. Section members also participated as judges of the essays received during this year's contest. # **Local Government Law Section**

# **Charles Eric Young, Chair**

#### Membership

As of September 1, 2016 had 625 members.

#### **Budget**

The budget for fiscal year 2016-2017 was 9,740. The Section spent \$9,877.48 and collected \$9,774.00 during 2016-2017 accruing a budget deficit of \$137.48. The deficit is the result of the Board of Governors allocating an additional \$500.00 to the Fellowship Program and the travel reimbursements exceeded the expected expenditures. However, the Board decided to award the fellowship at the planned amount rather than deducting \$137.38 from the student's stipend.

#### Journal of Local Government Law

The Board published three issues of the Journal during 2016-2017 and worked to produce an expanded issue in the summer of 2017. The three journals published included articles on the state of Zoning Law after *EMAC*, *LLC v. County of Hanover* and on Proffers after the amendments to Section 15.2-2303.4. Both of which have profound impacts on land use regulation in the Commonwealth. The Journal also included an article on Private Activity bonds. Perhaps the most widely read Article addressed the ramifications of the U.S. Supreme Court's ruling in *U.S. v. McDonnell*.

The Board also dedicated time and effort to an issue of the Journal expected in summer 2017, *Counterintuitive Issues in Local Government Law*. The entire issue will be dedicated to fundamental issues of local government law that are inconsistent with most rules of law controlling non-governmental parties. The Board embraced the fact that in many ways the local government client is unique and accepted the challenge of refreshing the recollection of members and non members of the section. For example, respecting the separation of powers, Virginia courts traditionally apply the fairly debatable standard when reviewing local government decisions. Also, there are many special statutory limitations periods applicable to claims against local governments. Other articles will address the breadth of Sovereign Immunity and the limits of Dillon's Rule. The Board plans to share this article, via email, with all Judicial members of the bar, many of whom seldom encounter the local government as a party in litigation.

#### By Laws

The Board reviewed and revised the Section's bylaws for the first time since 1995, excising many provisions regarding the initial election of officers and establishment of the Board. At the same time the revisions focused on the future. For example the revisions replaced the term "print" with "publish" to take into account the fact that most communications are or will be accomplished via email.

#### Fellowship Expanded

Several years earlier the Board of Governors established a fellowship for rising third year law students who are summer associates for local government attorneys. The Board recognized that public employment does not offer the same pay as private employment and saw that as an impediment to local government attorneys being able to attract the best and brightest; at the same time financial pressures on law students inhibit their willingness to experience the practice of local government law.

The Board continued the fellowship during 2016-2017 and was able to increase the stipend from \$4,000.00 to \$4,500.00. The fellowship committee, led by Board Secretary Lesa Yeatts, worked very hard to winnow a larger than expected pool of qualified applicants to a single student.

#### Showcase CLE

The Section co-produced a showcase CLE at the annual meeting. With the help of Board member Andrew McRoberts, the Section joined with the Real Property Law Section to produce an entertaining and informing seminar on the affects of amendments to Section 15.2-2303.4 of the Code governing proffers. Previously land developers who required rezoning of their property to accomplish their development could be asked by the locality to make improvements to local infrastructure which was not directly impacted by the proposed development in exchange for the rezoning. The revision requires that the locality may only ask for improvements to infrastructure directly impacted by the proposed development. The CLE included well reasoned, energetic debate between counsel for local government and counsel for developers, regarding whether the revisions actually will accomplish their intended purpose.

#### **New Members**

The Board changed its practice of having only Board members on the nominating committee. Instead, the Board enlisted three Section members who were not Board members to serve on the five member committee. The result was a strong slate of new members to replace the unusual number of members who were leaving the Board due to term limits.

The new members are Dawn Figueiras of Bristol, Virginia, Ken Golski of Loundoun County, Paul Mahoney of Roanoke, T.W. Bruno of Richmond, and Andrew Painter of Leesburg. The committee and the Board sought to preserve the geographic balance

among the membership, having members from Prince William County, Fairfax, Chesapeake, Virginia Beach, and two from Richmond already on the Board.

#### **New Officers**

The Section continued its practice of advancing the Vice Chair to Chair for the following year. Eric Gregory will be the Chair for 2017-2018. Unfortunately, the current Secretary Lesa Yeatts was not eligible for re-election to the Board due to term limitations and, thus, could not be advanced to Vice Chair. However, the Section was fortunate that Jan Proctor of Chesapeake agreed to serve as Vice Chair and Rebecca Kubin of Virginia Beach agreed to serve as Secretary, both for 2017-2018.

#### Membership:

In June of 2016, the Military Law Section had 290 members. By June of 2017, the section membership was down slightly to 264 members.

#### Funds and Budget:

The Military Law Section began the year with \$4,175.00 and ended the year with \$1,056.95. The Section's annual budget is \$5,000.

#### Section Activities:

The Military Law Section had a successful year! As a result of increased demands and limited resources, for the Spring 2016, and succeeding, CLE offerings we partnered with Virginia CLE, with Virginia CLE assuming the greater logistics/administrative responsibilities and with a sliding-scale fee structure. Due to some scheduling issues, we were only able to sponsor one CLE program over the course of the year. The Spring CLE was held at Quantico, this time on May 19, 2016 (Sexual Assault Prosecutions in the Military—LCDR Adam Partridge; Defending Military Sexual Assault Cases—LCDR Michael Hanzel; Practice Before the Military Discharge Review Boards—Brian Pristera; A View From the Bench—CAPT Chuck Purnell; Psychology of Sexual, Emotional, Economic and Psychological Assault on Victims and Their Subsequent Perspectives—Dr. Sadie Sheafe; and Ethics – Prescott L. Prince) and offered 6 hours of CLE.. Once again, the program was an outstanding success, and the move to Virginia CLE was highly appreciated as the right thing to do.

Aaron Moores worked hard to get a Spring 2017 newsletter out, however, it was postponed to Fall 2017.

The MLS continued to partner with the Attorney General's Office of Virginia in sponsorship of a number of clinics, that were held throughout the Commonwealth, that provided free legal assistance clinics to military personnel and veterans. These clinics continued to be a resounding success!

# **Tax Law**

The Virginia State Bar's Taxation Law Practice Section had approximately 700 members throughout the July 2016 – June 2017 fiscal year.

This past fiscal year was a time of transition for the Tax Law Practice Section. In an effort to increase activities and programs for the section, selection of a new Board of Governors began during the past year. Craig Bell was appointed as the interim chair by the outgoing chair. He was tasked with reconstituting and reinvigorating the Tax Law Section's Board of Governors and its activities.

During this fiscal year a great emphasis was made to identify and select new governors representing all areas of Virginia. By conclusion of the fiscal year, six governor representatives from the Tidewater-Hampton Roads, central Virginia, and Western Virginia areas agreed to serve as new governors. Two additional candidates are being sought from Northern Virginia. When complete the new board of governors will be appointed to their terms of office. The new governors will represent a diversified tax practice including in-house tax counsel, private tax practitioners from small, medium and large law firms, and a representative from a Low Income Tax Clinic. The focus of section activities will be on both transactional tax matters, as well as federal, state and local tax controversy practice areas.

During the past fiscal year the Tax Law Section served as co-sponsor of the William and Mary Law School Tax Conference. The section had several of its members serve on the Program Committee for the Tax Conference and five of its members made presentations at the three day conference held at the Kingsmill Resort in Williamsburg on November 9-11, 2016. Approximately 150 lawyers and accountants attended the tax conference. The section also provided financial support for the program.

The Tax Section also served as a co-sponsor of the University of Virginia Federal Tax Conference held in Charlottesville on June 8-9, 2017. Again our section was active in planning the content for the conference as well as providing multiple speakers for the two day event. The section also provided financial support for the program. The program was well received, with approximately 135 attendees hosted at UVA's Darden Graduate Business School.

Our plan is to formally stand up the new Board of Governors during the summer. We want to hit the ground running this Fall.

#### Membership

#### 35th Annual Trusts and Estates Seminar

In October, the Trusts and Estates Section co-sponsored the 35th Annual Trusts and Estates Seminar with Virginia CLE. The program was held in Roanoke, Williamsburg and Fairfax. In addition to the usual surveys of Federal and Virginia law developments and ethics, topics included recent tax developments, fiduciary litigation and income tax basis issues at death.

#### **VSB Annual Meeting CLE Program**

Also in October, the Trusts and Estates Section joined with the Diversity Conference and Virginia CLE in sponsoring a CLE regarding autism in the legal profession for the Annual Meeting to be held in June 2017. The proposed program was approved by the BAM Committee (for a 1.5 hour presentation) and took place on June 16, 2017.

Each edition included four articles on relevant and timely trust and estates topics and was distributed to all members of the section by e-mail. # Conference of Local and Specialty Bar Associations

Any local or specialty bar association in the Commonwealth of Virginia may be a member of the conference upon request in writing to the Executive Committee of the Conference, through the Executive Director of the VSB, supplying the names and addresses of its president and any other officers or staff. Of the 132 bar associations of which the Virginia State Bar is aware, 123 are members of the CLSBA.

The Bar Leaders Institute was held at the Lewis Ginter Botanical Garden on March 10, 2017. ABA Past President Robert Grey was the keynote speaker. There were 80 registrants for this program. Topics for the day included Resources for Bar Associations; Nuts and Bolts of Bar Leadership; Bar Projects Showcase; Ethics for Bar Leaders – Duty to Care; and How Bar Leaders Can Successfully Engage Members of the Bench in Local Bar Events and Functions. We would like to thank the BLI subcommittee that put together a phenomenal program – Chuck Lollar, Marcus Scriven, Lewis Martin and Luis Perez. The fearless foursome is planning the 2018 BLI, which will be held Friday, March 9, 2018, in Richmond.

On September 19, 2016, the CLSBA presented the Solo & Small-Firm Practitioner Forum in Winchester. Topics of the day included Technology, Cybersecurity, Financial & Business Arrangements with Clients, Appellate Practice, and Arbitration. The day offered 5 hours of live CLE, with 4 hours of Ethics. There were 169 registrants for this program.

Similar to previous programs, the CLSBA hosted the Solo & Small-Firm Practitioner Forum/Bench-Bar Conference and Town Hall Meeting in Emporia on October 24, 2016. Topics of the day included Technology, Cybersecurity, What to Do/Not Do in the Courtroom, Evidentiary Issues Across the Border; and GAL/Children. The Town Hall Meeting included Judge Marla Decker of the Virginia Court of Appeals and Judge Robert N. Hunter Jr. of the North Carolina Court of Appeals. Many thanks to the VSB Bench-Bar Relations Committee for their planning of the Bench-Bar portion of the program. The day offered 5.5 hours of live CLE, with 3 hours of Ethics. There were 147 registrants for this event.

On April 10, 2017, the CLSBA presented a Solo & Small-Firm Practitioner Forum at the Holiday Inn in Downtown Lynchburg. The program was similar to the Winchester event except there were no appellate or technology sessions. The Diversity Conference participated in this event and presented on the changing realities and considerations in the practice of law in the Commonwealth of Virginia. The day offered 5 hours of live CLE, with 3 hours of Ethics. There were 233 registrants for this event.

This year's CLSBA Annual Meeting and Breakfast took place on Friday, June 16, at 7:30 a.m. at the Sheraton Virginia Beach Oceanfront Hotel. As always, we had a great turnout. The Local Bar Leader of the Year Award recipient was Heather Scott Miller from Leesburg. The winner of this year's Bar Association of the Year Award was the Charlottesville-Albemarle Bar Association. A new award was created this year to recognize a Specialty Bar Leader of the Year. This award went to Andrew J. Reinhardt from Richmond. There were six Awards of Merit, one for a multi-bar project, and one Certificate of Achievement presented this year. The CLSBA nominating committee report was read and approved unanimously. The members voted to update the CLSBA Bylaws and Constitution to include a name change to "Conference of Local and Specialty Bar Associations," provide for email notifications in the future, update the title of the staff liaison, and require advance approval of future bylaws changes by VSB Executive Committee and Council to bring the CLSBA in line with other VSB conferences.

The So You're 18 handbook has been distributed to schools, J&DR Courts, departments of social services, juvenile detention centers, and other groups/organizations as requested. The CLSBA Executive Committee is currently working on updates for the coming year.

The CLSBA continually seeks to improve its efforts to better serve the needs of Virginia's local, statewide and specialty bar associations, to identify best practices and inform bar leaders of developments and trends on issues of importance to association leadership.

#### Special Activities/Programs/Achievements during the 2016-2017 Fiscal Year:

#### A. Third Annual Law School Mentor/Mentee Initiative - VSB Annual Meeting

The Diversity Conference invited and sponsored law students from each Virginia law school to attend the 2017 VSB Annual Meeting in Virginia Beach. Under this Initiative, Deans of each of the respective law schools in Virginia select two of their outstanding students whom they feel reflect their schools' respective diversity goals and excellence in studies. Each law student was paired with at least one practicing attorney from the Diversity Conference who served as mentor to the student. #### D. 2017 Oliver Hill/Samuel Tucker Pre-Law Institute

The Oliver Hill/Samuel Tucker Pre-Law Institute (HTI) was held on June 26-30, 2017 at the University of Richmond. Named for legendary civil rights attorneys Oliver Hill and Samuel

Tucker, HTI reaches future lawyers at an early age (high school) to provide them with exposure and opportunity to explore the legal profession, at no cost to the participants. Students in this year's HTI participated in various activities to include, among other things, a networking reception, sessions on closing and opening statements, and evidence, a mock trial, and an etiquette dinner. As in past years, the continued success of HTI was made possible with a grant from the Virginia Law Foundation and, for the first time as a funded Conference this year, from the budget of the Diversity Conference.

#### E. 2017 Students' Day at the Capitol/Rule of Law Program

The Diversity Conference co-sponsored and provided volunteers for the 2017 Students' Day at the Capitol/Rule of Law Program held on Wednesday, March 29, 2017. This program includes collaboration with the Virginia Law Foundation, Virginia Bar Association, VSB YLC, Rule of Law Project, and the academic community in the Richmond and Henrico Public School areas. Using a partnership with teachers, lawyers, judges, and students, the program seeks to provide students with an enriching and interactive experience about the importance of the rule of law in their daily lives. This program helps students better understand the need to preserve and protect the rule of law as the foundation for the rights and freedoms we enjoy in the United States.

#### F. YLC Bench-Bar Dinner

The Diversity Conference hosted 2.5 tables at the 2017 YLC Bench-Bar Dinner. Among other individuals, former Diversity Conference Board of Governors Chair and champion,

the Honorable Rupen Shah, was recognized for his elevation to judge of the 25th Judicial District.

#### G. Black Land Trust

The Diversity Conference participated in a meeting with representatives of the Black Family Land Trust, Inc. on May 30, 2017, at the VSB offices. The Black Family Land Trust (BFLT) is one of the nation's only conservation land trusts dedicated to the preservation and protection of African American and other historically underserved landowners' assets. The meeting was called by Karl Doss, VSB Access to Legal Services Committee, and the Chairs of the Diversity Conference and the Senior Lawyer Conference were invited to participate. The Old Dominion Bar Association, the Department of Agriculture and Forestry, and Professor Comer, College of Agriculture, Virginia State University, were also represented at the meeting.

The BFLT is seeking pro bono or reduced fee legal assistance and monetary support to support its mission in Southside Virginia. Discussion will be ongoing at the direction of the Access to Legal Services Committee. # **Senior Lawyers Conference**

The mission of the Senior Lawyers Conference of the Virginia State bar is to uphold the honor of the profession of law, to apply the knowledge and experience of the profession to the public good, to encourage cordial discourse and interaction among members of the Virginia State Bar and to serve the interests of senior lawyers and promote the welfare of seniors generally.

The Senior Lawyer Conference Board of Governors consists of twenty four members (currently 2 vacancies) of diverse backgrounds representing the Commonwealth and hailing from the Valley, Northern, Central, Northern Neck, Coastal and Southside Virginia. The board is a group of seasoned seniors dedicated to service to others and the advancement of the highest standards of the legal profession. The SLC had the lead role for the February 2017 Issue of the Virginia Lawyers Magazine.

The Senior Lawyers Conference (SLC), created in 2001, is the successor of the Senior Lawyers Section which was established in 1987. Membership is automatic and limited to lawyers in good standing who have attained age fifty five (55) years and is around 18,901members. The SLC deals with matters of interest for senior lawyers and senior citizens in our communities. The core programs are Senior Citizen Law Days, Pro Bono legal services and Fifty Year Awards at each Virginia State Bar Annual Meeting. In addition over the past 6 years the conference solicited donations to purchase and deliver over 15,880 trees (seedlings) to individuals and organizations throughout the state free of charge. The project was concluded this year and the fund balance was used for a \$1,000.00 scholarship in honor of John Tate, the SLC founder of the project, for a student attending his alma mater, William and Mary.

Throughout Virginia, seniors from all walks of life appear uninformed or powerless regarding legal issues affecting them. Yet many assets are available to assist them including free will clinics, Senior Law Day Programs, pro bono services and the recent Statewide Senior Legal Helpline. Senior Citizens Handbooks for participants in legal seminars are available free of charge. These programs are designed to educate and empower seniors regarding their legal affairs. Many retired attorneys continue to provide pro bono services and we are seeking more volunteers. Some law firms graciously continue to support their retirees with office space and administrative assistance.

There were 222 identified members of the Fifty Year Class of The Virginia State Bar. They were admitted to practice between July 1, 1966 and June 30, 1967. They are scattered over 18 states, Arizona, California, Colorado, Connecticut, Georgia, Florida, Maryland, Michigan, New Jersey, New York, North Carolina, Pennsylvania, South Carolina, Texas, Utah, Vermont, Virginia and Washington and in D.C and Panama. Twenty eight members were recognized during the 50 Year Awards Brunch on Saturday June 17th during the 79th Annual Meeting of the Virginia State Bar in Virginia Beach.

# **Young Lawyers Conference**

In the 2016-2017 Bar year, the Young Lawyers Conference maintained its momentum and continued to operate as an engine of exceptional programming, pro bono work, and high-energy outreach and volunteer activity. The re-organization of our geographical representation structure from circuits to districts allowed us to simultaneously reduce our expenses and increase our engagement in areas of the Commonwealth outside of the population centers. Our ten District Representatives, tied into our leadership through on-on-one relationships with Board of Governor liaisons, have been engaging in collaborative outreach with local Bar young lawyer sections, or creating them where they do not yet exist, and working with them to further our goals and mission. We are already seeing dividends from these enhanced relationships: spreading existing programs and resources to new, appreciative audiences and also benefitting from a pipeline of new ideas and talent from our community partners.

Because our Conference comprises nearly 11,000 members and an extremely diverse constituency, we offer a continuous stream of programs and initiatives too numerous to set out fully. Our two-dozen active committees each organize at least one event per year, and some put on as many as four. Our website, quarterly *Docket Call* newsletter, and social media outlets detail our activities throughout the year, and I recommend them as the definitive record of our accomplishments. Highlights these year came from all quarters - our Professional Development Conference continues to grow in scope and scale, expanding to 255 participants at six sites across the state. Our Immigrant Outreach Committee was busy and expanded its offerings by partnering with community organizations. Our Oliver Hill/Samuel Tucker Institute partnership with the Diversity Conference continues to thrive, and our Bench Bar Celebration Dinner was thrilled to hear from Chief Judge Gregory of the 4<sup>th</sup> Circuit Court of Appeals as we honored ten newly-appointed women and minority judges.

The YLC also continues to lead innovation in the Bar, debuting online registration for the PDC and many other programs, launching the Practice Tips Series online publication with sixteen articles already and more forthcoming, and creating a Wellness Initiative in collaboration with Lawyers Helping Lawyers to take a proactive and progressive approach toward the health, happiness, and longevity of Virginia lawyers.

Finally, as always, we are immensely grateful for the support of our VSB Liaisons. Maureen Stengel is our stalwart ally and champion, and this year we welcomed Dolly Shafner, who stepped in for Catherine Huband who was a long and valued partner in our success.

# **Budget and Finance**

The Standing Committee on Budget and Finance met on April 27, 2017, to review and approve the staff's proposal for the FY 2018 operating budget. The budget was reviewed and approved by the Executive Committee on June 14, 2017. On June 15, 2017, Bar Council considered, and unanimously passed, an operating budget of \$14.9 million for FY 2018. Chief Justice Lemons communicated the Court's preliminary approval of the budget as submitted on June 9, 2017, to Karen Gould, Executive Director and Chief Operating Officer.

The budget reflects a decrease of approximately \$10,000 over the budget for the prior fiscal year which ended on June 30, 2017. The budget includes a 3% performance pay increase for VSB employees effective July 10, 2017, as authorized by the General Assembly. The pay increase is for all salaried positions as of April 10, 2017, and subject to performance criteria.

The Committee continues to evaluate the appropriate levels of reserves and dues for the Bar.

# **Lawyer Discipline**

### David J. Gogal, Chair

The Standing Committee on Lawyer Discipline oversees the attorney disciplinary process, including the bar's investigation and prosecution of complaints. Members of COLD are assigned to monitor the progress of investigations and prosecutions in each of the district disciplinary committees through interactions and discussions with VSB counsel and committee chairs. In addition, the oversight subcommittee randomly reviews case files to ensure that VSB counsel handled them in a procedurally correct manner. In FY 2017, there were approximately 120 random reviews. Specific files are also reviewed if complainants or respondents have questioned the handling of a case, and in FY 2017 there were two such reviews.

COLD also formulates and presents proposed amendments to Part Six, Section IV, Paragraph 13 of the Rules of the Supreme Court of Virginia, which govern the disciplinary process. Proposed amendments are published for comment and then presented to the Virginia State Bar Council, which decides whether to petition the Supreme Court for adoption of the changes. In FY 2017, proposed revisions to Paragraph 13-24 were approved by the Supreme Court of Virginia by order dated December 15, 2016. COLD also proposed revisions to Section 54.1-3935 of the Code of Virginia concerning procedures for three-judge hearings. Those revisions were passed by the General Assembly, effective July 1, 2017.

The committee is comprised of ten attorneys, two laypersons, and one member of the VSB Disciplinary Board, who serves ex officio. In FY 2017, the committee met every other month from August through June. David J. Gogal, served as chair of COLD and the rules subcommittee, and Beverly P. Leatherbury, served as vice chair of COLD and chair of the oversight subcommittee.

COLD hosts an annual Disciplinary Conference which is attended by attorney and lay members of the district committees, the Disciplinary Board, COLD members, and judges who sit on three-judge circuit court panels that hear disciplinary matters. The programs at the conference are designed to provide education and updates on the disciplinary process to the volunteers serving in the disciplinary system. The FY 2017 conference was held at Wintergreen Resort on July 27 and 28, 2017. Attendees included 155 members of district committees, the Disciplinary Board and COLD.

# **Professionalism**

The Standing Committee on Professionalism is charged with responsibility for the administration and ongoing oversight of the Mandatory course on Professionalism, which is required of all newly-admitted active members of the Virginia State Bar. The purpose of the course is to encourage attorneys to uphold and elevate the standards of honor, integrity and courtesy in the legal profession. Since institution of the program in 1988, over 39,000 new admittees have taken the course—significantly more than the current number of active Virginia licensed lawyers.

The course faculty is comprised of distinguished lawyers and judges representing a broad cross-section of the legal profession in Virginia. Faculty members are nominated by their peers, lawyers and members of the judiciary as well, voted and approved by the Standing Committee on Professionalism, and invited by the Chief Justice to accept appointment for a three-year term.

The course was offered a total of eight times during the 2016-2017 bar year as follows: three times in Northern Virginia, twice Richmond, and once in Roanoke, Chesapeake and Charlottesville . There were approximately 1,291 attendees at these courses. The committee noted the decline in attendance and presumes that was due to lower enrollment in law school. In addition, there is an all-day faculty training event each Fall for both new and returning members.

The committee was also privileged to welcome the Honorable B. Waugh Crigler, the Honorable Joel Cunningham, the Honorable Jeri K. Somers, the Honorable Lawrence Leonad, the Honorable Charles E. Poston, the Honorable Robert Ballou and Joseph A. Condo as luncheon speakers this year. The participation of our judicial officers, as well as the leadership of our Bar, in the course emphasizes to new lawyers the importance of the Professionalism Couse . The committee is grateful for the attendance of the current VSB President, Michael W. Robinson, at each of the courses and for his speeches at the plenary sessions.

The committee continues to oversee the administrative functions of the course including faculty selection, course material update and faculty training activities. Also, as the committee chair, I review course evaluations and strive to update the course agenda and format. Our faculty and committee member, Elizabeth Chupik, has spearheaded a subcommittee to update the hypotheticals used in the course workshops. Work is ongoing in the hope of publishing some of those new fact scenarios in October, 2017.

Finally, the committee continues to work with the Professionalism for Law Students program co-sponsored by the VSB Section on the Education of Lawyers. This

program has become a fixture at all the Virginia law schools and has been skillfully led by John Bredehoft and Frank Telegadas with the help of their committed faculty.

It has been my pleasure to serve as chair of this committee for three years. I am pleased to inform you that the committee approved the Honorable David Lannetti as the new chairperson and that he has accepted and assumed the chairmanship.

# **Unauthorized Practice of Law**

# James M. McCauley, Chair

After consultation with the Office of the Attorney General, the Virginia State Bar recommended to the Supreme Court of Virginia that the Court sunset the Standing Committee on Unauthorized Practice of Law. That committee was charged with two duties: 1) to investigate complaints alleging that individuals or business entities are engaged in the unauthorized practice of law; and 2) to issue opinions as to whether specific conduct constitutes the unauthorized practice of law. These responsibilities will continue to be handled by ethics staff with oversight from the VSB Clerk of the Disciplinary System (a nonlawyer) on the recommendations of Assistant Ethics Counsel, with the exception of straight dismissals.

This fiscal year, staff opened twenty-four (24) new UPL investigations; and of these new complaints, five (5) were closed due to insufficient evidence, three (3) were dismissed with caution, and one (1) was resolved by letter agreement. No investigations resolved this fiscal year were referred to the Office of the Attorney General for civil prosecution or to the U.S. Attorney's Office or to a commonwealth's attorney for criminal prosecution. Of the fifteen (15) remaining open complaints, seven (7) are under investigation, seven (7) are being reviewed by the VSB Clerk, and one (1) is in the initial stage of review.

During this year, Assistant Ethics Counsel also reviewed thirty-five (35) complaints, thirty-three (33) of which were determined, based on the information provided, not to be the unauthorized practice of law in Virginia warranting a formal investigation, and two (2) of which are outstanding.

A total of twenty-two (22) investigations were carried over from prior fiscal years. Of these, five (5) were closed due to insufficient evidence, two (2) were dismissed with caution, and six (6) were resolved by letter agreements. There were four (4) referrals to the Office of the Attorney General, and one (1) referral to commonwealth attorneys for prosecution. None of the investigations of prior years during this fiscal year were referred to the U.S. Attorney's Office. Of the four (4) remaining open investigations, one (1) is currently being reviewed by the VSB Clerk, one (1) is under investigation, and two (2) are in the final stages of review.

The Study Committee for Revision of the UPL Rules (SCRUPL) is tasked with reviewing and drafting revisions to the Virginia Unauthorized Practice of Law Rules and the definition of the Practice of Law in Virginia. SCRUPL, as of this writing, has met on two occasions, April 25, 2017 and June 21, 2017. Their next meeting is August 10, 2017. A subcommittee of SCRUPL is preparing a second draft of proposed revisions to the definition of the Practice of Law in Virginia.

#### 2016-17 Priorities

The Access Committee identified the following priorities for 2016-17:

- Demystifying pro bono by addressing the apparent fear that lawyers seem to have about doing pro bono.
- Incentivizing pro bono participation by Virginia lawyers.
- Making pro bono service easier for volunteer lawyers.
- Recognizing "pro bono champions" by presenting them with certificates
  or lapel pins (similar to LSNV's "6.1 Society" in which volunteer lawyers
  are presented gold, silver and bronze lapel pins based upon the amount
  of pro bono service provided).
- Developing a means of tracking of pro bono hours.
- Developing a mentoring program for pro bono lawyers.
- Increasing media coverage of access to justice issues in Virginia
   Lawyers Weekly and local newspapers, including the business benefits
   of pro bono.

- Developing a targeted campaign to promote pro bono service similar to Florida's "One" campaign.
- Provide more information/training to the bar re. Rule 6.1 and what service does and does not qualify as pro bono per the Rule.
- Possibly drafting proposed amendments to Rule 6.1 to clarify the definition of pro bono.
- Engaging lawyers to do pro bono work in "non-jailable" criminal matters in which indigent defendants are not eligible for the appointment of a public defender/court appointed counsel.

#### Meetings:

The Committee met in Richmond on 8/31/2016, 1/31/2017, and 5/9/2017 and during the joint Pro Bono Conference/Virginia Legal Aid Conference in Hampton on 10/26/2016.

Over the course of the Bar Year, the Access Committee worked on a variety of access to justice issues through its subcommittees.

- Awards Subcommittee reviews nominations for and recommends recipients of the Legal Aid, Oliver Hill Law Student Pro Bono and Lewis F. Powell, Jr., Attorney Pro Bono Awards (Chair – Rachel Jones; Members – Polly Chong, Crystal Twitty). Met on 8/23/2016 and 4/4/2017.
- Pro Bono Training/CLE Subcommittee recommends topics, presenters, and speakers for various Access Committee-sponsored trainings and events including the annual Legal Aid Luncheon and Pro Bono Conference (Chair – Tara Casey; Members – Hon. Yvette Ayala, Mark Braley, Paul Garrett, and Chip Nunley). Met on 2/28/2017 and 3/28/2017.
- Rules Subcommittee (formerly Unbundling of Legal Services
   Subcommittee) develops a proposal for amendments to the Rule of
   the Supreme Court of Virginia re. unbundling of legal services and
   emeritus attorneys (Chair Ali Fannon; Members Valerie L'Herrou,
   Chip Nunley, James McCauley, advisory member; John Whitfield,

- Alternative Delivery Systems Subcommittee a new subcommittee formed at the May 2017 Access Committee meeting to consider the role of nonprofit law firms, legal incubator programs, and LRAP programs "deploying" attorneys to rural areas in Virginia and other innovative means of delivering legal services to low income persons in addressing the justice gap (Chair – Valerie L'Herrou; Members - Hon. Yvette Ayala, Jennifer Dean, Razan Fayez, and Chip Nunley). First meeting was scheduled for 7/12/2017.
- Funding Subcommittee explores opportunities to increase public and private funding of Virginia's legal aid offices (Chair – Chip Nunley; Members - Marie Appleby, Mark Braley, and Tara Casey). No meetings in 2016-17.
- Social Media Subcommittee develops policy, establishes guidelines, and provides oversight of the Access Committee's potential use of social media for outreach to the Bar and members of the public

concerning access to justice issues, pro bono trainings, events and service opportunities (Chair – Jennifer Dean; Members – Karl Doss, Chris Fortier, advisory member). No meetings during the 2016-17 bar year.

- Online Pro Bono Website Subcommittee assists Access to Legal Services Director to develop strategies for lawyer recruitment and public marketing strategy for Virginia.freelegalanswers.org. (Chair – Karl Doss; Members – Marie Appleby, Hon. Yvette Ayala, Tara Casey, Chip Nunley, and Adrienne Sakyi) No meetings during 2016 -17 bar year.
- Legal Education Access Subcommittee considers how to increase
  access to justice by reducing barriers posed by the cost of a law school
  education for students and graduates interested in public sector
  careers. (Chair Open; Members Mark Braley, Jennifer Dean, Valerie
  L'Herrou and Chief Magistrate Yvette Ayala; and Clarence Dunnaville,

  Subcommittee was suspended.

During regular Access Committee meetings, subcommittees would report on their work and receive input from the entire committee. Over the course of the year, the committee and subcommittees heard about and discussed access to justice issues with numerous guests, including Michael Robinson, VSB President; Doris Causey, VSB President-elect; James McCauley, VSB Ethics Counsel; Gale Cartwright, VSB Director of Member Compliance; John Whitfield, Co-chair Virginia Access to Justice Commission and Executive Director, Blue Ridge Legal Services; David Neumeyer, Executive Director, Virginia Legal Aid Society(VLAS); Kristine Smith, Pro Bono Director, VLAS; Frances White, Pro Bono Project Coordinator, VLAS; Chris Fortier, Chair- elect, VSB Young Lawyers Conference; Hon. S. Bernard Goodwyn, Justice, Supreme Court of Virginia; Shantelle Argyle, founder, Open Legal Services, Salt Lake City, UT; and Jonathan Short, Executive Director, Route 1 Legal, Alexandria.

#### Virginia.freelegalanswers.org:

Virginia freelegalanswers org, the online, interactive, pro bono guestion and answer website, will note its one year anniversary on August 22, 2017. The Virginia State Bar hosts the website, which is one of over thirty Free Legal Answers sites that the ABA launched since 2016. Free Legal Answers provides legal information and assistance to low and moderate income Virginians in civil legal matters. Eligible clients are Virginia residents who have income levels of 250% of the federal poverty guidelines (or a household income of just over \$29,000 per year for a single adult). This eligibility threshold is higher than that for legal assistance by legal aid offices and most non-profit legal service organizations. Clients register for the website by logging in and answering a series of questions regarding their income, residence and assets. Once they have been approved to use the service, they may post questions on three different civil legal issues/matters over a twelve month period. Attorneys who are licensed and in good standing with the Virginia State Bar may register to provide limited scope, pro bono assistance after reviewing questions in the Free Legal Answers queue, selecting a question to answer, and responding to the question based on applicable Virginia or federal law. The client and attorney may engage in an online dialogue and even share documents and photos via the website. Attorneys remain anonymous during the interaction with the client and their service on the website is covered by malpractice insurance provided by the ABA and the National Legal Aid & Defender Association. Once the question has been answered, the attorney closes dialogue and clients are sent a customer service survey. Free Legal Answers is convenient for the clients and

volunteer attorneys as they may access the service anytime and anywhere they are able to log onto the internet – even from their smartphones.

During the early months of Free Legal Answers, the VSB Access to Legal Services Committee, with the support and assistance of VSB leadership, commenced a campaign to share information about the service to the public and recruit volunteer lawyers. The VSB Communications Department created a Free Legal Answers logo and marketing materials and the Access Committee developed and distributed business cards, flyers, brochures and pamphlets for the public on Free Legal Answers and other low cost legal resources and heavily promoted the website on social media. These efforts have seen significant growth in the number of clients (779 including 450 registered clients), volunteer lawyers (222) and questions asked (375) and answered (365) as of July 10, 2017. Client feedback from customer service surveys have been overwhelmingly positive.

Amendments to the Rules re. Emeritus and Unbundling of Legal Services:

On May 9, 2017, the Access to Legal Services Committee considered amendments to Part One, Rule 1:5 (Counsel – Unbundling of Legal Services) and Part Six, Section IV, Paragraph 3 (Classes of Membership – Emeritus Rule) of the Rules of the Supreme Court of Virginia.

The amendment to Par One, Rule 1:5 would allow attorneys to make limited appearances in civil court proceedings per written agreement between counsel and the limited scope client upon filing and serving of the appropriate notices with the court and opposing counsel/parties specifying the matters, hearing, or issues in which the limited scope representation is being provided. During the January 31 meeting, the Access to Legal Services Committee raised concerns about potential implications that the amendments to the Unbundling Rule might have upon ghostwriting and notice upon opposing counsel. These concerns were shared by the Virginia Access to Justice Commission during its March meeting. After receiving input from VSB Ethics Counsel James McCauley, the Access Committee determined that no further changes to the proposed amendment to the Unbundling Rule were necessary and, since the Access Committee had previously approved the amendment, no additional action was taken. The Unbundling Rule was referred back to the Access to Justice Commission which endorsed the amendments at its June meeting. The matter will be referred to the Supreme Court of Virginia for final consideration.

The Access to Legal Services Committee also considered of the Emeritus Rule. The Committee recommended that the emeritus lawyers should no longer be required to be supervised by a supervising attorney when providing pro bono services; however, they must be affiliated with a Qualified Legal Services Provider (i.e., legal aid or a nonprofit legal services organization). Additionally, emeritus lawyers must certify their QLSP affiliation and whether or not they are currently covered by professional malpractice insurance annually. The amendment further provides that to receive emeritus status, retired attorneys must submit to a competency review and provide the VSB Executive Committee with a letter from their physician certifying the applicant's competency. Retired and associate attorneys applying for emeritus status must also fulfill any outstanding MCLE obligations. The Committee unanimously approved the amendments to the Emeritus Rule and the proposed rule was submitted for public comment, ending on June 30, 2017 and for consideration by Bar Council at its October 2017 meeting.

#### Pro Bono Reporting:

During its meeting at the October 7, 2016, the Virginia State Bar Council narrowly voted

to not endorse the Virginia Access to Justice Commission's proposed amendments to Paragraph 18 of Part 6, Section IV of the Rules of the Supreme Court of Virginia and the comments to Rule 6.1 of the Rules of Professional Conduct concerning pro bono reporting despite the proposed amendments receiving the unanimously endorsement of the Access Committee and 80% positive feedback during the public comment period. These amendments provided for the annual reporting of pro bono hours and donations by Virginia lawyers to support programs that provide the direct delivery of legal services to low-income persons. The Access to Justice Commission decided to go forward with the pro bono reporting proposal at its March 2017 meeting without Bar Council's endorsement and submitted its recommendation for pro bono reporting for consideration by the Supreme Court of Virginia.

#### Free and Low Cost Legal Resources in Virginia Pamphlet:

In February 2017, the Access Committee published the Virginia State Bar "Free and Low Cost Legal Resources in Virginia". This eight page pamphlet is a guide for helping low-and modest-income Virginians find legal assistance and includes options for assistance by counsel and options for self-represented litigants. The VSB shall make the pamphlet available to legal aid offices, court clerk offices, law libraries, social service organizations and other venues where the public might go to obtain information about options for low cost assistance by counsel and self-help resources in civil cases. Initially 4,000 copies of the pamphlet were printed and approximately 3,000 copies have been distributed. A pdf of the pamphlet is also available for downloading/printing on the VSB website.

#### Conferences, Webinars, Seminars, and Presentations:

The 2016 Virginia State Bar Pro Bono Conference was held on October 26, 2016, in Hampton in conjunction with the Virginia Legal Aid Conference. This was the third time these events were held together, and attendees were welcome to attend sessions at either conference. The Pro Bono Conference featured CLE presentations "Representing Domestic Violence Survivors: Protective Orders and Pro Bono"; "Handling Uncontested Divorces: Nuts and Bolts for Pro Bono Lawyers"; and "Introduction and Demo: Virginia.freelegalanswers.org".

In order to increase outreach to and recruitment of pro bono attorneys as well as to provide training to legal aid lawyers, public defenders and court appointed attorneys on matters of substantive law, the Access to Legal Services Committee collaborated with legal aid organizations, law firms, non-profit legal services organizations, and bar associations to offer several webinars and seminars during the 2016-17 bar year. Attorneys who attended VSB Access Committee sponsored or co-sponsored programs certified that they will either accept a pro bono referral from a legal aid or non-profit pro bono legal services provider or make a financial contribution to one of these organizations. The Access Committee also conducted non-CLE programs for law students, social workers and members of the public and supported webinars developed by the Virginia Lawyer Referral Service, VSB Young Lawyers Conference, and the VSB Intellectual Property Section.

#### Awards and Recognition:

On October 26, 2016, during the Pro Bono Conference, the Committee presented the Lewis F. Powell, Jr., Pro Bono Award to the Harrisonburg law firm Hoover Penrod, PLC. VSB president Michael Robinson was the master of ceremonies and Jeffery Robinson, Deputy Legal Director and Director of the Center for Justice, American Civil Liberties Union, gave the guest remarks. More than 250 people attended this event. The Committee also introduced the Frankie Muse Freeman Organizational Pro Bono Award at the Pro Bono Conference. The award is named for Danville native and civil rights attorney Frankie Muse Freeman. Ms. Freeman was the lead attorney on the NAACP's landmark housing lawsuit, Davis et al vs. St. Louis Housing Authority, which ended legalized racial discrimination in public housing in 1952. The Freeman Award will recognize Virginia organizations that provide exemplary pro bono legal services to underserved Virginians. Ms. Freeman, who was 99 years old at the time, attended the event and was the honorary first recipient of the Freeman Award, which will be presented for the first time in 2017.

On June 16, 2017, during the Legal Aid Award Luncheon at the VSB Annual Meeting, the Committee presented the Oliver White Hill Law Student Pro Bono Award to Amber Strickland of the University of Virginia School of Law and the Legal Aid Award to Angela Ciolfi, Director of Litigation and Advocacy with the Legal Aid Justice Center. Don Saunders, Vice President of Civil Legal Services with the National Legal Aid & Defender Association in Washington, D.C., provided guest remarks. Over 100 persons attended this event.

The regional programs have had strong support from the local benches, the local bar associations, and members of the bar, both in planning and participation of each event. And each has been successful in bringing together large numbers of participants from the targeted region to provide a high-quality, live CLE opportunity in areas where such programs are difficult to find.

# **Future of Law**

The VSB Study Committee on the Future of Law Practice was charged with evaluating current developments and assessing how these changes will impact the practice of law. Since its inception in September 2014, the Committee met in person a minimum of six times each year. The Committee was asked to make recommendations for further study by the Bar. To that end, a report was generated which contained, among other things, seven recommendations, the final of which was that the Committee continue to study the evolving issues surrounding alternative business structures. The VSB posted its report for comment September 15, 2016

(https://www.vsb.org/docs/FINAL Report of the Study Committee.pdf). The goal of the Committee was to help illuminate the changing landscape of the practice of law both to help educate lawyers and to help prepare them for a future that is continually changing.

The Committee engaged in the extensive gathering of information, reading everything it could find on the future of law practice – articles, ethics opinions, and studies by other bar associations. Early on, the Committee determined that it should narrow the topics to explore and therefore divided itself into three subcommittees:

**Technology and the Practice of Law**—this subcommittee looked at advances in technology and how law practice is being changed by new technologies. It also studied how the Internet and other forces have created a market for non-lawyer legal service providers.

Access to Justice—this subcommittee focused on the "justice gap" - the unmet legal needs of a large majority of our low and middle income population despite an oversupply of lawyers in the U.S. It also focused attention on initiatives by the organized bar and the efforts of other organizations to address the justice gap, including some projects in other U.S. jurisdictions to allow licensed paraprofessionals to deliver legal services.

**Alternative Business Structures**—this subcommittee looked at jurisdictions outside the U.S. that permit nonlawyers to participate and have ownership in legal services firms, as well as the status of any similar initiatives or proposals in U.S. jurisdictions.

# Lawyer Insurance

# David D. Hudgins, Chair

\* The Special Committee on Lawyer Malpractice Insurance was renamed Special Committee on Lawyer Insurance on May 11, 2017.

ALPS Property & Casualty Insurance Company is the VSB's endorsed professional liability insurance carrier. The Special Committee on Lawyer Malpractice Insurance (LMIC)(renamed LIC effective 5/11/2017) continued its overview of ALPS's risk management endeavors during FY2016-2017.

At its first meeting in FY2017, on September 16, 2016, it was reported that ALPS successfully concluded its transition from a Risk Retention Group under the federal Liability Risk Retention Act to a fully admitted carrier in all states it does business. Policyholders benefited with the change in status by the availability of state guarantee funds, state regulation (the Virginia State Corporation Commission / Bureau of Insurance), new opportunities to serve law firms via other lines of insurance, and new avenues for strategic growth when desirable. ALPS reduced its total number of shareholders from approximately 1,200 to less than 500 via a 600-to-1 reverse stock split. All fractional shares less than one full share were in effect redeemed by ALPS.

In addition to the September 2016 meeting, the LMIC met on November 15, 2016, February 21, 2017, and May 11, 2017 in FY2017. At each of those meetings, the LMIC received a report from Chris Newbold, Executive Vice President regarding ALPS overall results, ALPS results in Virginia and Virginia risk management activities. As reported at the May 2017 meeting, at the end of the second quarter of 2017, ALPS posted assets of \$115,128,466 with policyholder surplus of \$39,212,781. The Virginia book had \$3.5 million of gross written premium and net written premium of \$2.3 million. Virginia's net combined ratio through the second quarter of 2017 was 55.23%, compared to ALPS 93.68%. Virginia insured law firms were 1,367 and insured attorneys stood at 604, out of ALPS total insured law firms of 4,623 and 1,947 lawyers. Claims frequency was 2.56% in Virginia compared to 2.49% through the second quarter for ALPS overall.

#### **Risk Management Programming**

Risk management revenue for calendar year 2017 was budgeted to be \$312,776 (ALPS 3% contribution = \$289,606; Non-ALPS attendees at Fall Ethics Tour = \$23,170). Total expenses are budgeted at \$312,740, to support a variety of ALPS risk management activities in Virginia. The 3% is a condition of ALPS endorsement agreement with the Virginia State Bar, permitted by statute. The money is held and spent by ALPS in a risk management program in Virginia overseen by the VSB Special Committee on Lawyer Insurance.

As of the end of the second quarter of 2017, expenses amounted to \$79,864.22. Revenue stood at \$72,437.91. The risk management budget will support the following programs during calendar year 2017:

**On–Demand Programing:** Currently, 16 programs exist in the Virginia on-demand library. They range in length from 45 min to three hours. New on-demand programs have been added throughout the year. Charges for the on-demand seminars are as follows: programs for one hour \$35 for insureds, \$65 for non-insureds; two hour programs \$45 for insured, \$75 for non-insured; and three hour programs \$60 for insureds, and \$90 for non-insured. **Quarterly Result:** In Q1, ALPS had 87 VA registrants for on-demand programs, with 85 ALPS insureds and 2 non-insured.

**YTD Result:** YTD, ALPS had 87 VA registrants for on-demand programs, with 85 ALPS insureds and 2 non-insured.

#### Webinar Programming:

In Q1 ALPS did one webinar.

On February 22nd ALPS did Exploring Common Business Relationships Between Lawyers. This was presented by Mark Bassingthwaite. There were registrants, with 35 insureds and 2 non-insureds.

**Quarterly Result:** In Q1, ALPS had 48 VA registrants for Webinars, with 45 ALPS insureds and 3 non-insured.

**YTD Result:** YTD, ALPS had 48 VA registrants for Webinars, with 45 ALPS insureds and 3 non-insured.

ALPS has made an effort to hit all of the main areas of the state again this year, in each week. All of these venues are booked. The script is completed and filming of the vignettes took place in April. ALPS has the final versions in hand now. The Ethics committee will work with Mark to develop the answer set in Q2.

#### Spring 2017 Tour

The Spring tour happened as follows:

- 3/27 Abingdon: 50 total registered 38 attendees + 9 walk ins, 12 no shows
- 3/28 Danville: 15 total registered 11 attendees + 1 walk in, 4 no shows
- 3/29 Lynchburg: 31 total registered 22 attendees + 6 walk ins, 9 no shows
- 3/30 Fredericksburg: 65 total registered 39 attendees +7 walk ins, 26 no shows

Total: 161 total registered – 100 attendees + 23 walk-ins, 51 no shows

This was a repeat of last fall's tour program and included Jim McCauley and Seth Guggenheim from the VSB Ethics Committee and a local attorney on the panel with Mark B. The feedback from these events was positive from the attendees. Jim McCauley expressed concern about the low number of attendees in Danville. It was decided not to do the Spring tour next year because of the relatively high cost, the VSB's reluctance to commit Jim McCauley's time to the program, and the low number of attendees.

#### **Local Programs and Events:**

**VSB TechShow** took place on April 24, 2017. ALPS contribution of \$30,000 from the Risk Management Fund was used to supplement technology at the Richmond Convention center.

#### Mission Statement Amended and Committee Name Changed

In addition to its usual business at the May 2017 meeting, the LMIC took up the issue of amending its mission statement. The Special Committee on Personal Insurance was sunsetted by the Executive Committee in April 2017 due to lack of activity. Accordingly, the LMIC's mission was expanded to incorporate the reports of Robert Spicknall, who is president of the Virginia State Bar Members' Insurance Center. The Lawyer Malpractice Insurance Committee was renamed the Lawyer Insurance Committee, "LIC", to reflect the change in its responsibilities. The LIC's mission was amended to include the responsibility of oversight of the VSB Life and Disability Plans and activities related to assisting members of the VSB in procuring medical insurance plans. In providing this oversight, the LIC will make recommendations, when needed, to the Executive Committee and to Bar Council as to what individual or firm should serve as a personal insurance liaison for the VSB.

# Lawyer Referral

The Virginia Lawyer Referral Service (VLRS), 'Celebrating 40 Years' of effective and high-quality customer service has received 11,971 calls from persons in need of assistance with possible legal matters in Virginia. Of those calls, the VLRS has provided 4,318 prescreened and prepaid referrals to its active panel members; resulting in \$160,150.00 non-profited revenue for the bar.

The Virginia State Bar (VSB) Special Committee on Lawyer Referral commends the 389 VLRS attorney panel members for their (past and present) service to the bar and their communities. The VLRS welcomed 50 first-time panel members. The Committee's efforts was to bring awareness of the VLRS to the VSB members by promoting the value of its panel membership; the consumer service and the protection provided to its callers to ensure their legal needs were being met. Those goals were met by:

1. Sponsorship of two (3 CLE credited) webinars: "Introduction & Mission of the Virginia State Bar (VSB) Virginia Lawyer Referral Service and Ethics for the Virginia Lawyer Referral Service (September 14<sup>th</sup>); Defense of Criminal Cases: Introduction and Estates, Trusts and Wills (September 28<sup>th</sup>)

Presenters: D. Adam McKelvey, Crandall & Katt; Charles Adams, Zwerdling, Oppleman & Adams; and Joley L. Steffens, Esq., ThompsonMcMullan. VSB members attending the webinars received 1-year VLRS panel membership.

- 2. On-Site Panel Membership promotions: VSB TechShow (Richmond), Solo and Small-Firm Practitioner Forum (Emporia & Winchester), VSB YLC Admission & Orientation Ceremony (Richmond), The Virginia Bar Association (VBA) 46<sup>th</sup> Annual Conference on Labor Relations and Employment Law & 127<sup>th</sup> Annual Meeting(Williamsburg); The Old Dominion Bar Association (ODBA) Annual Meeting (Woodbridge); and the VSB Annual Meeting (Virginia Beach).
- 3. A featured article in the VSB Virginia Lawyer Magazine (April 2017), "What We Do Here: The Virginia Lawyer Referral Service"; along with new print advertising inviting VSB members in the practice of Employment, Immigration, and Consumer laws with bilingual abilities to the service's panel membership.

- 6. Reviewed lawyer panel membership Disciplinary Administrative Hold for the protection of the consumers and panel members.
- 7. Plans to develop an interactive online referral portal for the general public.
- 8. Partnering with The Greater Richmond Bar Association (GRBA) to provide referrals to Virginia Veterans that contacted their office for legal services.
- 9. Changes to the Virginia Lawyer Referral Service website to make it more consumer friendly (less wording) and more visually appealing to the reader.
- 10. Statewide consumer advertising and promotion by distributing over seventhousand VLRS Take-One Rack Cards to Virginia State Libraries (40), the Virginia General District, Juvenile & Domestic Relations, and Circuit Courts (107), and the Virginia Public Defender Offices (26).

# **Resolution of Fee Disputes**

The Virginia State Bar resolution of fee dispute program (RFD) was created as a voluntary program to help attorneys and clients resolve disputes over fees and costs paid, charged, or claimed for legal services provided by a member of the Virginia State Bar (VSB). The program achieves this goal by providing two options—mediation and binding arbitration. Parties who choose the mediation process but who do not reach a satisfactory conclusion may still utilize the binding arbitration process.

The RFD program benefits VSB members and the public by reducing needless litigation, spurious bar complaints, and Clients' Protection Fund petitions.

During FY2016-17, the VSB made efforts to make the RFD more robust:

- The RFD coordinator contacted RFD circuit committee chairs to assess volunteer needs.
- In the fall, VSB conducted fee dispute training in Richmond, Roanoke, Fairfax, and Norfolk with approximately 100 trainees in attendance.
   Due to new training, volunteer interest has increased, the VSB is in the process of reinstating a former circuit committee that dissolved due to lack of volunteers, and the VSB has added volunteer arbitrators and mediators to those circuits in need of additional volunteers.
- The VSB has applied term limits for volunteer arbitrators, mediators, and circuit chairs, to align with those of similar VSB committee volunteer requirements.

The VSB RFD received 212 requests for information during fiscal year 2016-2017.

Out of those 212 requests:

- Petitioners returned 86 agreements to circuit chairs for processing (64 from clients, 22 from attorneys);\*
- 39 of those agreements were accepted by the respondent;
- 13 attorney respondents declined to participate;
- 11 cases were settled prior to mediation or arbitration; and
- 31 cases went to FRD: 18 cases are complete (9 mediations and 9 arbitrations) and 13 are pending (8 mediations and 5 arbitrations).

(\*Note: Report includes half year stats for circuit 2)

Geographical breakdown of requests:

- 22% were for attorneys practicing in eastern Virginia (circuits 2, 3/4);
- 44% were for attorneys practicing in NOVA (circuits 16, 18, 19, 31);
- 23% were for attorneys practicing in central Virginia (circuits 12/13/14);
   and
- 11% were for attorneys practicing in south/southwestern Virginia (circuits 10, 23, 24, 28).

The VSB continues to seek ways to encourage VSB member participation and to publicize and promote the RFD at VSB-related events, including the Solo & Small Firm Practitioner Forums, Bar Leaders Institute, VSB-sponsored CLEs, through local bars, and other events.

# Technology and the Practice of Law

The mission of the Special Committee on Technology and the Practice of Law is to educate and advise the Bar and the public, in areas where law and technology intersect. During the past year, the Committee has continued to meet once per month by telephone conference call, and gathered one time in person for an annual meeting in Richmond. Frequent meetings have allowed us to share ideas and maintain forward progress on a number of activities.

Through two-person teams, the Committee has continued to present its two CLE programs: "Practicing Law in the Digital Age: Successfully Leveraging Technology for Your Practice and Trials," and "Let's Talk Tech: Bringing Lawyers and Technology Together in an Ethical and Practical Way," as well as excerpts from them to various bar associations (local bar associations; Virginia Association of Defense Attorneys; and the Virginia Trial Lawyers Association). The Committee has recently established a working group of its members, tasked with updating CLE materials so that the Committee can continue its mission to bring current technology information and education to attorneys around the state through ongoing CLE programs.

Individual Committee members volunteer to write a brief column for each issue of the *Virginia Lawyer*.

This website will be regularly updated by Committee members, and a working group of members is developing recommendations as to how the web site can most efficiently be utilized to deliver information and key resources to members of the Virginia Bar on an ongoing basis. We are also in the process of developing scripts for short video presentations, each on a technology topic, which would be both educational and effectively communicated in a verbal/ visual format; Virginia CLE has offered to partner with us to produce video presentations, and our goal would be to have the videos posted and available on the website.

# The Clients' Protection Fund Board

The Clients' Protection Fund was established in 1976 to make monetary awards to people who have suffered financial losses because of the dishonest conduct of Virginia lawyers. The fund is managed by a fourteen-member board appointed by the Virginia State Bar Council. Board members investigate all petitions from clients for payments from the fund. The board hears each petition and determines the amount of loss.

As of July 1, 2016, forty-nine (49) claims were pending from the previous year. In FY 2017, fifty-two (52) new petitions were received. The total amount paid during 2016-2017 was \$343,428 .86 representing fifty (50) claims. The board denied fourteen (14) petitions, and thirteen (13) petitions were rejected for not meeting the CPF rule requirements. One (1) claim was withdrawn by the petitioner. As of June 30, 2017, there were twenty-three (23) pending claims. The board reviewed and investigated sixty-two (62) claims during the year.

The fund began the fiscal year on July 1, 2016, with a cash balance of \$8,309,226. The Clients' Protection Fund \$25 assessment from all active attorneys totaled \$805,600. Interest income, net of bank service charges for the fiscal year, totaled \$110,900. The fund received restitutions from attorney general's collections, debt set-off, and individual restitutions in the amount of \$34,251 net of attorney's fees for collection services. As of June 30, 2017, the cash balance in the fund was \$8,911,684.

The Clients' Protection Fund board members are to be commended for the many hours spent investigating and deliberating claims submitted to the board. In addition, to performing its regular work reviewing petitions, the board undertook and completed two major strategic tasks in 2016-2017. First, our Finance Subcommittee provided extensive leadership and strategic recommendations when challenged by the upheaval in the global financial markets which had rippling effects on our Clients' Protection Funds after the Brexit vote in June 2016. Additionally, our Rules and Procedures Subcommittee provided an extensive detailed review and revision of the board's governing rules and procedures for operation. After many hours of review and deliberation of the extensive recommendations presented by both subcommittees, these amendments were approved by the entire board. Notably, Bar Council unanimously approved our recommendations for amendments to the Client Protection Fund Rules and Procedures at its February 2017 meeting. Finally, appreciation is extended to retiring board member Doris Henderson Causey after her years of service on the board.

The board welcomes Paul G. Gill from the third disciplinary district as a new member for the fiscal year 2017-2018.

# **Mandatory Continuing Legal Education**

The Mandatory Continuing Legal Education (MCLE) Board administers the program that was established by the Supreme Court of Virginia in 1985. The rules governing the MCLE program were amended in 1990 to require all active members of the Virginia State Bar to complete a minimum of twelve hours of approved continuing legal education courses, including two hours of ethics or professionalism, each fiscal year.

The MCLE Board consists of twelve members appointed by the Virginia Supreme Court. In addition to the chair, members for fiscal year 2017 included, George W. Watkins of Waynesboro, Vice Chair, Darius K. A. Davenport, Sr. of Suffolk, Afshin Farashahi of Virginia Beach, Lori Beth Galbraith of Chesapeake, Zachary A. Kitts of Fairfax, Victoria N. Pearson of Richmond, Kimberly A. Pierro of Mechanicsville, Christine L. Poarch of Salem, Cynthia M. Radomsky of Fairfax, Liza S. Simmons of Richmond, and Lorrie A. Sinclair of Leesburg.

The Board meets seven times per year at the VSB's Richmond office to, among other things, consider course-approval applications, requests for extensions and waivers, and other matters integrally related to the MCLE process in Virginia. The VSB's MCLE department provides daily administration of the MCLE requirements for the Board. Over the last reporting cycle, the MCLE staff and Board considered the following: 21,395 course approvals, 59 waiver and extension requests and approximately 163,011 certifications of attendance. Usage by attorneys of the online MCLE certification feature continues to increase and enables attorneys to post the majority of their certifications of attendance directly to MCLE record and view current MCLE record 24/7, saving time, money and effort for both our members and the MCLE department. For the 2016 MCLE compliance year over 75% of the course attendance was certified by the members online. Two hundred thirty-eight (238) members have taken advantage of the iPhone app for connecting to the member login portal.

Over the last reporting cycle, the Board continued to study the topics of diversity and bias in the legal profession to determine (1) if alternative approval standards are warranted and, if so, (2) what modifications should be recommended. The Board continued to study and draft changes to Opinion 16 Distance Learning Programs to allow for new gaming formats. Opinion 14 Written Materials was amended and published for public comment. The Board will consider the comments for possible final amendments in the coming year.

At the beginning of this year we welcomed new member, Victoria N. Pearson of Richmond, to the Board. At the close of the year, three of our members completed their service on the Board: Afshin Farashahi, Cynthia M. Radomsky, and Lorrie A. Sinclair. The Board will miss their insight and dedication to the profession. As this year closes, I want to thank George Watkins for his fine service on the Board as member and Vice Chair and his willingness to serve the Board next year as Chair.

As always, the MCLE staff, directed by Gale M. Cartwright, ensures that the MCLE process runs smoothly for both the MCLE Board and the membership of the Virginia State Bar. The staff conscientiously provides institutional memory for the MCLE Board, even as members of the MCLE Board come and go over time. I want to thank the staff for their good work throughout this year. I especially want to thank Ms. Cartwright for her tireless efforts and her daily oversight of the MCLE process throughout the Commonwealth and her sage advice to the Board. Finally, the MCLE Board is grateful for the assistance of the Executive Director of the Virginia State Bar, Karen Gould, who also provided continued guidance to the Board.
