Bar Activities, Officers, and Council During 2017-2018

Doris Henderson Causey of Richmond served as president of the bar from June 18, 2017, until June 17, 2018. Significant VSB Rule and Statutory Developments 2017-2018

Clients' Protection Fund

The Supreme Court of Virginia entered an order on September 28, 2017, reducing the amount Virginia's active lawyers pay into the Clients' Protection Fund from \$25 to \$10, effective July 1, 2018.

The VSB received permission from Council and the Supreme Court of Virginia to ask the General Assembly to extend the Clients' Protection Fund assessment contained in Va. Code § 54.1-3913.1 for another three years and was successful in having that measure pass and be signed into law, effective July 1, 2018. This means that the assessment will no longer terminate on July 1, 2020, but will terminate on July 1, 2023, if no further action is taken.

The Clients' Protection Fund was established in 1976 to make monetary awards to persons who suffered financial losses due to the dishonest conduct of Virginia lawyers. The total amount paid during FY2017-2018 was \$103,130.58 for 27 claims. Fifteen petitions were denied, and 11 petitions were rejected for not meeting the CPF rule requirements. The fund balance as of June 30, 2018, was \$9,765,666. The CPF assessment paid by active VSB members raised \$813,060 in FY2017-2018.

Voluntary Pro Bono Reporting

Effective December 1, 2018, the Rules of the Supreme Court of Virginia, Part 6, Section IV, will include a new provision, Paragraph 22, that requests each active VSB member report their pro bono hours and/or financial contribution in support of pro bono legal services on their annual dues statement. The reporting complements the aspirational goal of Virginia Rule of Professional Conduct 6.1 that each lawyer should render at least two percent of professional time annually to pro bono legal services.

Emeritus Status Rule Change

Effective March 1, 2018, the Supreme Court of Virginia approved changes to the rules governing emeritus status in the Virginia State Bar. Among other things, the amendments to Paragraph 3(e) of Part 6, Section IV of the Rules of the Supreme Court of Virginia alter the number of years an attorney must have been engaged in active practice before becoming an emeritus member, and they abolish the requirement to practice under the direct supervision of legal aid attorneys.

Specifically, Paragraph 3(e) was changed to enable members who have practiced law for 20 years or more and who are an active, associate, or retired member in good standing of the Virginia State Bar to become emeritus members (Paragraph 3(e)(1)(B)(ii) of Part 6, Section IV of the Rules of the Supreme Court of Virginia). The member must not have been the subject of discipline by any bar or court within the past 15 years (Paragraph 3(e)(1)(B) (iii)). The member must have been engaged in the active practice of law for a minimum of five out of the seven years immediately preceding the application to become an emeritus member (Paragraph 3(e)(1)(B)(iv)). The changes allow those who qualify as emeritus members under the new rule to provide pro bono services without being under the direct supervision of a supervising attorney after certifying annually his or her affiliation with a qualified legal services provider (Paragraph 3(e)(4)(B)).

The Report of the National Task Force on Lawyer Well-Being was issued in the Fall of 2017, which has started a profession-wide discussion regarding the problems of lawyer depression, substance abuse and addiction and how to address them. The Honorable Donald W. Lemons, Chief Justice of the Supreme Court of Virginia, appointed a Well-Being Committee to investigate and discuss these issues. As a result of the Well-Being Report, the VSB undertook an initiative to address various issues raised by the Report and proposed various rule changes.

Proposed Rule Changes to Deal with Well-Being Issues

Council approved rule changes at its June 14, 2018 meeting, dealing with disciplinary and membership processes that may be helpful to attorney well-being. **The proposed rule changes were presented after the meeting to the Supreme Court of Virginia for approval.**

Proposed revisions to Rule 1.1, Competence

The amendment would add Comment [7] to Rule 1.1:

[7] A lawyer's mental, emotional, and physical well-being impacts the lawyer's ability to represent clients and to make responsible choices in the practice of law. Maintaining the mental, emotional and physical ability necessary for the representation of a client is an important aspect of maintaining competence to practice law. See also Rule 1.16(a)(2).

•Proposed revisions to Paragraph 13-1 and 13-30 regarding a Lawyer Assistance Program.

The amendments would address the following changes (additions denoted by underlining and deletions by stippling):

- 13. PROCEDURE FOR DISCIPLINING, SUSPENDING, AND DISBARRING ATTORNEYS
- 13-1 Definitions

<u>"Lawyer Assistance Program" means a mental health and/or substance abuse treatment</u> program for Attorneys that is approved by the Bar.

13-30 Confidentiality of Disciplinary Records and Proceedings

* * *

M. Disclosure of Information to Lawyer Assistance Program. If Bar Counsel believes that an Attorney may benefit from the services of a Lawyer Assistance Program, Bar Counsel may make an informal referral to a Lawyer Assistance Program and may share information deemed confidential under this Paragraph as part of that referral. Bar Counsel shall not share information that is protected from disclosure by other state or federal privacy laws. Bar Counsel may, but shall not be required to notify the subject

Attorney of the informal referral or transmission of confidential information to the Lawyer

Assistance Program. Unless the subject Attorney has signed a release allowing the

Lawyer Assistance Program to share information with Bar Counsel, the Lawyer

Assistance Program shall not report information about the subject Attorney to Bar

Counsel, and Bar Counsel shall not receive such information from the Lawyer

Assistance Program.

- Proposed revisions to Paragraph 13-23 and Paragraph 3 regarding change of membership for impaired attorneys.
 - 13. PROCEDURE FOR DISCIPLINING, SUSPENDING, AND DISBARRING ATTORNEYS

13-23 Board Proceedings Upon Impairment

A. Suspension for Impairment. The Board shall have the power to issue an order of Suspension to a Respondent who has an Impairment. The term of such Suspension shall be indefinite, and, except as provided below, shall be terminated only upon determination by the Board that Respondent no longer has the Impairment. A Respondent who intends to rely upon evidence of an Impairment in mitigation of Misconduct shall, absent good cause excusing his or her failure to do so, provide notice not less than 14 days prior to the hearing to Bar Counsel and the District Committee or Board of his or her intention to do so. A finding of Impairment or transfer to the Disabled and Retired class of membership under Paragraph 13-23.K may be utilized by Bar Counsel to dismiss any pending Complaints or allegations of Misconduct on the basis of the existence of exceptional circumstances a finding of Impairment or a transfer to the Disabled and Retired class of membership militating against further proceedings, which circumstances of Impairment shall be set forth in the Dismissal.

* * *

K. Bar Counsel may terminate and close an Impairment Proceeding if the
Respondent transfers to the Disabled and Retired class of membership pursuant to Part
6, Section IV, Paragraph 3 of the Rules of Court and files a declaration with the Clerk of
the Disciplinary System and the Virginia State Bar's Membership Department that the
Respondent will not seek transfer from the Disabled and Retired class of membership.
The declaration shall be endorsed by the Respondent and the Respondent's counsel or
Guardian Ad Litem. Termination of the Impairment Proceeding shall not be considered a
final order in an Impairment Proceeding under Paragraph 13-30. The Respondent's
transfer to the Disabled and Retired class of membership and filing of the declaration
pursuant to this subparagraph may be utilized by Bar Counsel to dismiss any pending
Complaints or allegations of Misconduct on the basis of transfer to the Disabled and
Retired class of membership, militating against further proceedings, which shall be set
forth in the Dismissal.

* * *

(d) Disabled and Retired Members—Any member of the Virginia State Bar upon attaining the age of 70 or on the basis of a permanent disability, may submit to the executive director of the Virginia State Bar a written request to be transferred to the disabled and retired class of membership. Members who are electing this status based on a permanent disability must submit adequate medical and/or psychological documentation with the request. Members qualifying for transfer to the disabled and retired class shall not be entitled to practice law. Further, such members shall not be eligible to vote or hold office in the Virginia State Bar. Disabled and retired members who have not filed a declaration with the Clerk of the Disciplinary System and the Virginia State Bar's Membership Department that the member will not seek transfer from the Disabled and Retired class of membership pursuant to Paragraph 13-23 may submit a petition to the executive director in writing for reinstatement to active or associate membership and state in the petition each circumstance that has changed since the member elected disabled or retired status. Adequate medical and/or psychological documentation must be submitted with the petition showing that the member is fit and capable of practicing law. If there are any misconduct complaints or proceedings pending when the executive director receives a petition for reinstatement, or if the member appears to suffer from a disability, the executive director shall defer consideration of the petition until the misconduct or disability issues are resolved. The Executive Committee of the Virginia State Bar shall consider and act on any such petition, taking into account the recommendation of the executive director. The Executive Committee may deny a petition for reinstatement if the member is publicly disciplined or is determined to have a disability raising a serious question as to the member's fitness or capacity to practice law. If the Executive Committee approves the petition, the member shall be returned to active or associate status upon payment of the appropriate dues, satisfaction of any other required membership obligations, and payment of any outstanding financial obligations to the barVirginia State Bar. Medical and/or psychological information provided pursuant to this subparagraph (d) is confidential and shall not be disclosed by the barVirginia State Bar.

Opinion 19

The MCLE Board has amended Opinion 19. Revised Opinion 19 makes clear that lawyer well-being topics will be considered for CLE credit, so long as other MCLE requirements are satisfied. The opinion provides examples of topics and programs that may receive regular CLE and ethics/professionalism credit.

MCLE Opinion #19 - Programs Promoting Lawyer Well-Being.

In 2009, the MCLE Board issued the first edition of this Opinion, which was entitled "Substance Abuse, Mental Health Disorders, Stress, and Work/Life Balance Topics." In that edition of this Opinion the MCLE Board noted the following:

The MCLE Board is concerned about the effects of substance abuse, mental health disorders, stress and work/life balance on legal practitioners in the Commonwealth of Virginia and on the quality of legal services provided to the public. Because the MCLE Board believes that education on these topics will be

beneficial in addressing these issues, it will consider topics pertaining to substance abuse, mental health disorders, stress management and work/life balance for CLE credit under certain circumstances.

In August 2017 the ABA National Task Force on Lawyer Well-Being (the "Task Force") issued a report entitled "*The Path to Lawyer Well-Being: Practical Recommendations for Positive Change*" (the "Lawyer Well-Being Report"). In the Report, the Task Force correctly found the following:

To be a good lawyer, one has to be a healthy lawyer. Sadly, our profession is falling short when it comes to well-being. . . [T]he current state of lawyers' health cannot support a profession dedicated to client service and dependent on the public trust.

While the MCLE Board has in the past granted credit for lawyer well-being programs, the MCLE Board hereby emphasizes that programs promoting lawyer well-being may be approvable for CLE credit, so long as other requirements applicable to all CLE programs are met. In addition, programs must be clearly and primarily designed, directed to, and intended for attorneys, not a general audience.

By way of example, and not limitation, topics that may be approvable for CLE credit include the following:

- Substance abuse
- Mental health disorders
- Stress, sources of stress, recognizing stress, the effects of stress, minimizing stress, and stress avoidance
- Work/life balance
- Navigating the practice of law in a healthy manner
- Cognitive impairment
- Process addictions
- Burnout
- Depression
- Suicide awareness and prevention
- Promotion of civility in the profession[1]
- Promotion of mentoring
- Promotion of lawyer autonomy and control over lawyers' schedules and lives
- Enhancement of optimism
- Promotion of resilience
- Promotion of diversity in the profession

As in the general population, the legal profession is aging and lawyers are practicing longer, which raises unique lawyer well-being issues. In order to promote the profession and provide quality legal services, the following

programs are examples of topics that may be approvable for CLE credit when dealing with aging attorneys:

- Programming for detecting and addressing cognitive decline in oneself and colleagues
- Development of succession plans
- Options available to guide and support transitioning lawyers

Training for the legal profession in identifying, addressing, and supporting fellow professionals with mental health and substance abuse disorders is vital. Acknowledging this, the following topics are examples that may be approvable for CLE credit:

- The warning signs of substance abuse or mental health disorders, including suicidal thinking
- How, why, and where to seek help at the first signs of difficulty
- The relationship between substance abuse, depression, anxiety, and suicide
- How to approach a colleague who may be experiencing problems with mental health, depression, or substance abuse
- How to thrive in practice and manage stress without reliance on alcohol or drugs
- Self-assessment or assessment of others of mental health or substance abuse risk
- Lawyer assistance programs

The Task Force has further found the following:

[G]enuine efforts to enhance lawyer well-being must extend beyond disorder detection and treatment. Efforts aimed at remodeling institutional and organizational features that breed stress are as crucial, as are those designed to cultivate lawyers' personal resources to boost resilience. All stakeholders should participate in the development and delivery of educational materials and programming that go beyond detection to include causes and consequences of distress.

Such topics may be appropriate for CLE credit, among others.

Programs on lawyer well-being that focus the presentation and written instruction materials on ethics or professionalism may receive ethics credit. By way of example, and not limitation, ethics credit may be provided for the following topics:

- Well-being presentations that focus on ethical considerations addressed in the Rules of Professional Conduct
- Lawyer well-being programs that address issues that may trigger the reporting requirements of the Rules of Professional Conduct

- Programs designed to help lawyers reconnect with, strengthen, and apply their values, strengths of character, and sense of purpose toward achieving outstanding professionalism
- Programs designed to support the development of organizational cultures within firms, law departments, and legal agencies that recognize, support, and encourage outstanding professionalism

Credit will only be provided for programs clearly and primarily designed, directed to, and intended for attorneys, not a general audience.

Revision of the Definition of the Practice of Law and UPL Rules

The Study Committee to Study the UPL Rules, appointed by then president Michael Robinson in June 2017, issued its recommendations, which are now posted for comment.

Specifically, following a year-long review by a Virginia State Bar Study Committee to Revise the Unauthorized Practice of Law Rules ("the Study Committee"), the Study Committee recommended revisions to the definition of the practice of law and the deletion of Unauthorized Practice of Law Rules 1-9 with replacement by an entirely different format. The Study Committee reviewed the existing definition of the practice of law and the nine existing individual UPL rules. It reviewed other jurisdictions' UPL definitions and rules and reviewed state and federal law that create exceptions to the UPL Rules for certain activities performed by non-lawyers. The Study Committee determined that a better format was necessary, including a general definition of the practice of law followed by sections describing exceptions to and exclusions from that definition and finally comments and annotations explaining and providing examples of these exceptions and exclusions. Some content from the existing rules was included in the proposed revisions. All of the revisions include conduct or activity that has been and continues to be the subject of UPL complaints and the current rules and UPL Opinions.

The proposed definition more succinctly and clearly sets out the general prohibition against the unauthorized practice of law, a definition of the practice of law, exceptions (i.e., activity that is the practice of law but which nonlawyers and foreign lawyers may perform), exclusions (i.e., activity that is not considered the practice of law), commentary, and annotations.

At its May 16, 2018 meeting, the Standing Committee on Legal Ethics unanimously approved the Study Committee's proposal and determined that it addresses regulation of unauthorized practice of law in Virginia more comprehensively, clearly and concisely than the existing definition and rules.

Criminal Discovery Reform

In January 2018, the VSB's Criminal Discovery Reform Task Force announced it had unanimously approved proposals addressing rules for reciprocal disclosure of witness lists and expert witness information, as well as exchanging witness statements, and sharing police reports and witness statements with defense counsel. The proposals are pending with the Judicial Council's Advisory Committee.

Specifically, proposals were forwarded to the Judicial Council's Advisory Committee on Rules of Court for consideration at its meeting in April 2018, which then posted them for comment. the proposed reform would expand the scope of the limited discovery currently permitted under Rule 3A:11. The most significant proposal would permit the accused or defense counsel to inspect reports prepared by law enforcement officers. The proposed amendments would also require the reciprocal exchange of witness lists by defense counsel and the commonwealth's attorney and require defense counsel to provide expert witness information as required of commonwealth attorneys under the current rule.

LEO Approvals

LEO 1887, Duties when a lawyer over whom no one has supervisory authority is impaired, was approved by the Court on August 30, 2017, effective immediately.

LEO 1887 concludes that evidence of a lawyer's possible impairment, standing alone, does not necessarily trigger the duty to report misconduct under Rule 8.3(a). The impairment needs to be reported if the lawyer has reliable information about a violation of the Rules that raises a substantial question as to the lawyer's honesty, trustworthiness, or fitness to practice law. Rule 8.3(a). The opinion also encourages lawyers to contact Lawyers Helping Lawyers (LHL) or another lawyer assistance program, or to suggest that the possibly-impaired lawyer contact LHL, for guidance on how to address the underlying impairment regardless of whether a bar complaint is filed. The opinion also acknowledges that many lawyers feel a professional obligation to proactively report or address another lawyer's impairment, even though that obligation does not arise from the Rules of Professional Conduct.

LEO 1750, Solicitation and Advertising Issues, was approved by the Court on April 20, 2018, effective immediately.

LEO 1750 is a compendium opinion on advertising issues, in light of the significant updates to Rules 7.1 and 7.3 that took effect on July 1, 2017. Throughout the opinion, references to the Rules of Professional Conduct have been updated with the current "false or misleading" language of Rule 7.1, and references to since-withdrawn or modified LEOs have been removed or updated. Other revisions to the opinion include:

*Updating section C, Firm Names and Offices, with the current standard for firm names, and to incorporate the discussion of office rentals and other potentially-misleading firm addresses from LEO 1872;

*Revising section E, Participation in Lawyer Referral Services, to define the parameters of an appropriate lawyer referral service in light of the fact that many prior opinions on lawyer referral services have been withdrawn;

*Revising section F, Advertising Specific or Cumulative Case Results/Jury Verdicts/Comparative Statements, to reflect the fact that Rule 7.1 no longer requires a specific disclaimer when advertising case results, and to give examples of the context in which case results must be placed in order to avoid misleading the public; and

*Updating section I, Use of "Specialist" or "Specializing In," to include the current standard for advertising claims that a lawyer is certified as a specialist in a particular area of law.

LEO 1889 was approved by Council on June 14, 2018, and was forwarded to the Court for approval on June ____, 2018. This proposed opinion addresses whether a court-appointed lawyer has duty to appeal or continue representing a parent when that parent's parental rights have been terminated by a Juvenile and Domestic Relations District Court if the attorney has lost contact with the parent, the parent has not directed the attorney to appeal the matter, and the parent fails to appear in court or otherwise participate with the attorney in the course of the representation. In this proposed opinion, the Committee concluded that although the parent/client may have a right to court-appointed counsel and a right to appeal, the parent must communicate with the lawyer in order to exercise that right. The lawyer cannot exercise that right without the client's knowledge and consent.

Amendment of Disciplinary Proceeding Rules

The Supreme Court of Virginia approved the following amendments on 4/16/2018, effective 6/16/2018:

- Amended Paragraph 13 to correct CRESPA to RESA.
- Amended Paragraph 13-1 definition to clarify that administration and Impairment Suspensions are not part of a lawyer's Disciplinary Record.
- 3. Added Paragraph 13-1.1 to define the burden of proof in all Disciplinary Proceedings as clear and convincing evidence.

Report of the Office of Bar Counsel

Edward L. Davis, bar counsel

I. Overview

The Office of Bar Counsel (OBC) consists of the intake and discipline departments. The intake department initially receives and screens all inquiries to the bar about attorney conduct and proactively handles inquiries alleging minor misconduct. Intake also performs preliminary investigations in a limited class of cases. The discipline department receives complaints forwarded from the intake department and conducts investigations and prosecutions of such cases before district committees, the Disciplinary Board and three-judge circuit courts. It also petitions the circuit courts for injunctions and the appointment of receivers when such relief is necessary to prevent the loss of client property by dishonest lawyers, or when needed to wind up the practices of disabled, deceased or disbarred attorneys if no other person is reasonably able to do so.

II. Personnel Matters

There was little turnover in the OBC during the fiscal year. Two legal secretaries and one Intake analyst departed for employment opportunities in the private sector and with other agencies. The OBC hired Cassidy Revelo as a legal secretary in October 2017. Cassidy worked for two years as a paralegal at large law firms focusing on immigration services. Her experience in high volume, detailed work under tight deadlines and her fluency in Spanish have served the OBC well. In January 2010, Kelly Armentrout became the newest Intake analyst. Kelly is a graduate of James Madison University with five years of large and small law firm administrative experience. Finally, effective May 25, 2018, Suzette Walker became our newest legal secretary. Suzette brings more than 20 years of experience in the legal field. She worked for nine years in the Petersburg Juvenile and Domestic Relations District Court.

As discussed below in Part IV, the OBC chose not to fill three position vacancies created by the departures of attorneys in recent years. The result is a reduction in the number of discipline attorneys from 13 to 10. The OBC will keep the staff of attorneys at this level as part of its new strategic plan.

The April edition of the *Virginia Lawyer* included a profile of Assistant Bar Counsel Katie Uston concerning her role as President of the National Organization of Bar Counsel (NOBC). She completes her term on July 1, 2018. As NOBC President, Katie has been involved in the implementation of the recommendations made in the August 14, 2017 report of the National Task Force on Lawyer Well-Being. Chief Justice Lemons, who was a member of the National Task Force, organized a statewide task force to study the report and appointed Katie to participate. More information about the OBC's initiatives in adopting provisions of the Lawyer Well-Being Report appears below in Part V.

III. Production

As of June 25, 2018, there were 115 public trials, agreed dispositions and consents to revocation, a decrease of 8.7% from the 126 reported one year ago. The total volume of open cases, however, has dropped to 330 from 352 at the end of the last fiscal year, a decrease of 6.25%, and a reduction of 50.2% from the 663 total open cases five years ago. As of June 25, there were only seven "pre-017" cases remaining. This is the lowest that this number has ever been since I began reporting it ten years ago. The fiscal year began with 41 such cases. By comparison, the number was 250 ten years ago on July 1, 2008.

These reductions reflect continued increases in the processing of cases as well as the quality of attorneys and staff now at the bar. In addition, the intake staff continues to process more cases to conclusion through summary dismissals of complaints that do not affect the disciplinary rules, and the proactive resolutions of minor misconduct complaints without creating disciplinary records.

IV. Outlook

Last year, the OBC chose once again not to fill a position vacancy among its attorneys. The result was an overall reduction in the attorney staff from 13 to 10. The OBC also reduced its administrative support staff in recent years. The reasons for these reductions were budgetary and strategic in nature. We found that a high-caliber of attorneys and support staff enabled the OBC to reduce significantly the overall volume of open cases, as indicated above in Part III. Further, the new managerial structure implemented two years ago, with Ed Dillon and Brent Saunders serving as Senior Assistant Bar Counsel, has led to more timely review and issuing of charging documents in disciplinary cases. The OBC has kept a watchful eye on the dockets following this reduction in staff, and the numbers are improving. We will strive to continue this trend while meeting our public protection mission.

V. Changes to Procedural Rules and Rules of Professional Conduct

The OBC has been working on several recommendations for The Standing Committee on Lawyer Discipline (COLD) to consider that address the recommendations of the National Task Force on Lawyer Well-Being, issued August 14, 2017. On Saturday, February 24, 2018, the Virginia State Bar Council (Council) approved by unanimous vote changes to the disciplinary procedural rules developed and approved by COLD. Among the changes are clarification that a Disciplinary Record does not include administrative suspensions, such as impairment suspensions. This will remove the stigma of a disciplinary record from impairment, which addresses health concerns as opposed to attorney misconduct. Another rule change approved by Council clarifies that the burden of proof in all proceedings is clear and convincing evidence. Existing rules do not set forth the burden of proof in impairment cases. These changes represent the first of many steps toward implementing measures that emphasize lawyer well-being. On April 16, 2018, the Supreme Court of Virginia approved these changes, effective June 15, 2018.

At its meeting on March 7, 2018, COLD approved additional amendments to the procedural rules intended to address lawyer well-being. One proposal would facilitate "retirement with dignity" for a lawyer suffering from irreversible cognitive decline. It would allow transfer to the Retired/Disabled class of membership in lieu of an impairment suspension. The other proposal would allow the OBC to furnish confidential information to an approved Lawyer Assistance Program in an attempt to accelerate help to lawyers who need it. The proposal is on point with the report of the National Task Force on

Lawyer Well-Being, which recommends that when information indicating mental health or substance abuse issues is discovered during investigation or prosecution of lawyer regulation matters, confidentiality rules should allow sharing of such information with lawyer assistance programs. On Thursday, June 14, Council approved the proposed amendments by unanimous vote. They are now under consideration at the Supreme Court of Virginia.

At future meetings, COLD will continue to study the report of the National Task Force on Lawyer Well-Being and what amendments, if any, are needed to the Rules of Court to support lawyer well-being.

At its meeting on June 14, 2018, Council approved proposed Comment [7] to Rule 1.1 of the Rules of Professional Conduct, intended to address lawyer well-being. The proposed comment states that the maintenance of mental, emotional and physical ability is an important aspect of maintaining competence to practice law. The proposal is under consideration by the Supreme Court of Virginia.

On April 20, 2018, the Supreme Court approved Legal Ethics Opinion (LEO) 1750, the Advertising Compendium Opinion, effective immediately. The LEO clarifies the implications of the April 17, 2017 amendments to the advertising rules, RPCs 7.1 and 7.3.

The Study Committee for Revision of the UPL Rules (SCRUPL) had its final meeting on May 3, 2018, and on May 16, 2018, presented a revised draft of the Definition of the Practice of Law to the Legal Ethics Committee. The Legal Ethics Committee voted to release this version of the rule for public comment. The deadline for comments is July 13, 2018.

VI. Matters in the Supreme Court of Virginia

A. Reinstatement Cases

On January 11, 2018, Steven Frank Helm petitioned for the reinstatement of his law license. Mr. Helm consented to the revocation of his license on April 1, 2011, with disciplinary charges pending. Following an investigation, the Virginia State Bar Disciplinary Board will hold a hearing on the petition.

On February 9, 2017, Anne Marston Lynch petitioned for the reinstatement of her law license. Ms. Lynch consented to the revocation of her license on December 3, 2009, while disciplinary charges were pending. On December 8, 2017, Deputy Bar Counsel Kathryn Montgomery tried the case before the Disciplinary Board, which, by Order entered February 8, 2018, recommended against reinstatement. On April 16, 2018, the Supreme Court approved the Disciplinary Board's Order.

B. Appeals Decided by the Supreme Court of Virginia

As of June 25, 2018, the Supreme Court has decided no appeals during the current fiscal year. Two appeals are pending, as indicated below in Part VI.C.

C. Appeals Pending before the Supreme Court of Virginia

On June 13, 2018, Joseph Dee Morrissey noted the appeal of the revocation of his law license imposed by a three-judge circuit court on March 30, 2018, effective June 15, 2018. With his notice of appeal, he also filed a petition to stay the revocation pending appeal. Assistant Bar Counsel Christine Corey filed an opposition the following day. By Order, entered June 14, 2018, the Supreme Court denied the stay.

On June 6, 2018, the Supreme Court heard the appeal of a Public Reprimand issued to Thomas Hunt Roberts. A decision is pending. Assistant Attorney General Madeline Gibson represents the bar on the appeal.

Criminal Law

It has been an honor to serve as chair of the Virginia State Bar's Section on Criminal Law for the 2017-2018 bar year. My fellow officers included Nancy G. Parr, Vice Chair; Seth Weston, Secretary; and Colette McEachin, Immediate Past Chair.

The following members joined the board on July 1, 2017: Steven P. Milani of the Office of the Capital Defender in Roanoke and James D. Vinson of Randall Page in Emporia.

With a membership of 2,406 members, including 2,038 active members and 335 judicial members, the section remains the second largest section of the Virginia State Bar. Its operating budget for 2017-2018 was \$53,600.

Newsletter editor Professor Ron Bacigal, of the University of Richmond, published four issues of *Criminal Law News* during the year, and also completed the 2018 edition of the *Capital Case Trial Manual*.

The section sponsored its 48th Annual Criminal Law Seminar in February 2018, with a live session in Charlottesville on February 2, followed by a live Williamsburg session on February 9. Section Vice-Chair Nancy Parr served as seminar program chair and moderator. Total seminar attendance included 481 for the live February sessions, and an additional 165 for the video replays held in March and April.

Membership

As of June 2018, the Education of Lawyers Section had 344 members, compared to 508 last year. The membership included 196 active members, 47 judicial members, and 96 members of the Academy.

Budget

The board allocated \$5,000 to the Virginia Supreme Court's Rule of Law Day in Richmond on March 29, 2018. All but \$144 was spent on the program. On April 2, 2018, Virginia Supreme Court Justice Cleo E. Powell (member of Litigation Section Board of Governors, 2011-17) emailed "sincere and heartfelt thanks" for our "generous donation" on behalf of the Rule of Law Student's Day at the Capitol Committee.

Fall & Spring Newsletters (November 2017 & May 2018) were published electronically under the direction of our newsletter editor, Professor Jennifer Franklin of William & Mary Law School. These are available on the web site.

Local Government Law

Membership

As of June 1, 2018, the Local Government Law Section had 720 members, which is an increase from 625 members in September, 2016.

Budget

The budget for fiscal year 2017-2018 was \$10,000. By June 30, 2018, the Section expects to have spent \$6,002.68. As of May 21, 2018, the Section had collected \$12,840.00 during the 2017-2018 fiscal year. Depending on final year-end expenses, the Section expects to have a positive balance of approximately \$6,837.32, for fiscal year 2018.

Journal of Local Government Law

The Board published one issue of the *Journal of Local Government Law* during 2017-2018 and worked to produce additional issues in 2018-19. The Fall 2017 issue of the *Journal* included articles on "Searching Employees' Workstations", issues of privacy, and applicable Supreme Court cases, by John C. Blair, Deputy County Attorney for Albemarle County; and "The U.S. Supreme Court's New Standard for Students with Disabilities in Practice", by Laura A. Ferrugiari and Timothy M. Mahoney, son of longstanding section member Paul Mahoney, former County Attorney for Roanoke County, and published with the permission of the Nassau County Bar Association. The *Journal* also included a new "*Did you know...?*" feature by section member and Board of Governors Secretary Rebecca "Becky" Kubin, which explained that privately-held oyster leases in state-owned waters is a category of property that cannot be condemned by localities. The new "*Did you know...?*" column is meant to briefly highlight an obscure or little-known or understood issue of local government law that may be of interest to section members. All section members are invited to submit articles for consideration.

The issue also included a report from 2017 Local Government Fellowship Recipient, law student Callie Gibson. Ms. Gibson reported on her summer experience working with the Henrico County Attorney's office and expressed her appreciation to the section and Board of Governors for awarding her the fellowship.

Fellowship Expanded

Several years earlier, the Board of Governors established a fellowship for one or more rising second and third year law students who are summer associates for local government attorneys. The Board recognized that public employment does not offer the same pay as private employment and saw that as an impediment to local government attorneys being able to attract the best and brightest; at the same time financial pressures on law students inhibit their willingness to experience the practice of local

government law. The fellowship provides funds to support recipients during the summer months while they gain public service experience.

The Board continued the fellowship during 2017-2018 and budgeted \$4,000 for fellowship awards. The fellowship committee, led by Board Vice-Chair Jan Proctor, worked very hard in assessing a large pool of very qualified candidates. Ultimately, the fellowship committee recommended, and the Board of Governors approved, awarding two fellowships for the summer of 2018, each in the amount of \$2,000, to law students Jessica Lipford, who is splitting her summer between the Henrico and Dinwiddie County Attorneys' offices, and Sarah Silberman, who will be interning with the Arlington County Attorney's office.

New Officers and Members

The Board appointed a nominating committee for the purpose of nominating officers for the Board of Governors and new members for election to the Board of Governors to fill open seats and replace members who are rolling off the Board. In compliance with the new By-laws adopted last year, the Board enlisted three Section members who were not Board members to serve on the five-member nominating committee. The result was a strong slate of officers and new members to replace members who are leaving the Board due to term limits.

The committee nominated Jan Proctor to advance to the position of Chair for 2018-19 from her position as Vice-Chair for the 2017-18 year. Also nominated to advance from her previous position as Secretary was Rebecca Kubin, to serve as Vice-Chair. Bernadette Peele was nominated for the position of Secretary.

The terms of Board of Governors members Kevin White, Cynthia Bailey, and Section Chair Eric Gregory, expired. Members Kevin White and Cynthia Bailey were eligible to serve another term and were so nominated by the committee. Chair Eric Gregory rolled off the Board due to having already served two terms but will continue as immediate past Chair. The committee nominated J. Vaden Hunt, County Attorney for Pittsylvania County, to fill the open seat on the Board.

During the Virginia State Bar's Annual Meeting, the Local Government Section held its Annual Meeting on June 15, 2018. Section members present voted and unanimously elected the slate of officers and new member J. Vaden Hunt to the Board of Governors, as recommended by the Nominating Committee. Therefore, Section officers for 2018-19 are Chair Jan Proctor, Vice-Chair Rebecca Kubin, and Secretary Bernadette Peele.

Conference of Local and Specialty Bar Associations

Mission: Local and specialty bar associations in Virginia comprise the Conference of Local and Specialty Bar Associations. The conference was established to maintain a mutually beneficial relationship between the VSB and the local and specialty bar associations in the Commonwealth. It sponsors a Bar Leaders Institute each year to help new local and specialty bar officers plan their bar year and assists them with ethical issues, various programs and internal management policies and procedures; sponsors Solo & Small-Firm Practitioner Forums open to all VSB members; sponsors awards of merit, a Local Bar Leader of the Year Award, Specialty Bar Leader of the Year Award, and Bar Association of the Year Award; maintains an information database; and makes executive committee and staff members available for technical assistance or presentations to local and specialty bars. The conference publishes The Connection online newsletter with information of interest to bar leaders. The CLSBA also edits, prints and distributes the So You're 18 handbook, and created the www.soyoure18.com website, which is used by many groups to inform young adults of their rights and responsibilities upon turning 18.

The Bar Leaders Institute was held at the Lewis Ginter Botanical Garden on March 9, 2018. The Honorable Manuel A. Capsalis was our keynote speaker. There were 75 registrants for this program. Topics for the day included Social Media for Bar Associations; How to Plan a CLE; Bar Projects Showcase; You're the President, Now What?; Ethics for Bar Leaders; and Pro Bono: Why it's Important and How to Get Involved. We would like to thank the BLI subcommittee that put together another phenomenal program – Chuck Lollar, Marcus Scriven, Lewis Martin and Luis Perez.

On September 20, 2017, the CLSBA presented the Solo & Small-Firm Practitioner Forum in Kilmarnock. Topics of the day included The Future of Law, The Realities of Impairment, What to Do if You Receive a Bar Complaint and Tips on How to Avoid Getting One, and Fastcase 7. The Honorable Robert J. Humphries joined us and gave a lively presentation on appellate practice. There was also a great panel of local judges who shared their Top Ten Things to Do, or Not, in the Courtroom. H. Virginia State Bar Special Committee on Access to Legal Services projects

The Diversity Conference, in partnership with VSB Access to Legal Services Committee, has embarked on two language access projects. The first project underway is the translation of the *Free and Low Cost Legal Resources in Virginia* guide into Spanish. The Conference has coordinated volunteer members for this translation project in partnership with the Access to Legal Services Committee. Young Lawyers Conference

Just like that, the Young Lawyers Conference (YLC) is 45 years old! The YLC may not be a young lawyer by its definition (under age 36 or within the first three years of practice in your primary bar) but its membership and leadership had it active all year. The YLC had a membership of 9,163 as of July 1, 2018. This report does not cover all the activities of the YLC as there was a lot happening as the year progressed. However, the YLC leadership is grateful for everyone's time, effort, participation, and ideas to keep the organization active, relevant to its membership, in tune with the work of the Virginia State Bar and parallel with the work of the American Bar Association Young Lawyers Division and other state and local young lawyer groups nationwide, and useful for the public.

This year's Board of Governors were energetic and enthusiastic, providing the President much insight and assistance with programs and initiatives over the year. Their presence was the difference in supporting the operations of the YLC, engaging in the tough discussions and working solutions to the issues the YLC encountered over this bar year, and embracing a mindset of "how can we accomplish" to ideas or goals dreamt up internally or brought to the YLC by its membership or its affiliated organizations.

The YLC's Program Chairs, District Representatives, and volunteers breathed life into the organization with their enthusiasm and on the ground support. Their welcoming presence allowed the YLC to touch the lives of thousands of our members and many more in the public. Chris Fortier, YLC President 2017-2018, noted, "these people were the empowering force that kept me going as YLC President. Meeting them and working with them gave me new energy and I was able to return home from our events more determined to serve Virginia's young lawyers with the best that I could provide."

YLC Vision 2022: A Strategic Plan

In September 2016, a group convened to update the YLC's Long Range plan as it had not been updated in seven years. A group consisting of Chris Fortier, Brian Wesley, Missy York, and Kris McClellan met over the next year to draft a new plan. The group was able to examine the strategic plans of the Virginia State Bar and the American Bar Association Young Lawyers Division to ensure that the plan would be consistent with the objectives of the Virginia State Bar and serve the needs of tomorrow's young lawyers. The group also evaluated the Future of Law reports from the ABA and the Virginia State Bar. The group examined the YLC's mission statement and wrote a new purpose statement, and goals.

Mission Statement: The Young Lawyers Conference is committed to creating and supporting young lawyers as leaders in the bar through service to the public, service to the bar, and professional development opportunities in an inclusive environment that

builds on diverse experiences, empowering young lawyers to live up to the high standards and ideals of a Virginia lawyer.

Purpose Statement: The purpose of the Young Lawyers Conference is to:

- 1. Provide a means by which young lawyers may actively participate in leadership and activities of the Virginia State Bar;
- 2. Support activities that meet the needs of both young lawyers and members of the Bar:
- 3. Promote, uphold, and elevate the standards of honor, integrity, and competence in the legal profession;
- 4. Improve the legal system and the responsiveness of the profession to the public at large; and,
- 5. Foster diversity and inclusion among young lawyers and members of the Bar.

GOALS:

Goal 1: To prepare and nurture young Virginia lawyers through effective communication and organizational direction to formulate strong leaders in the YLC, VSB and the community.

Goal 2: To build social and professional networks among young lawyers, the VSB, and local and specialty bars

Goal 3 : To provide professional development relevant to young lawyers' needs and public service projects that fulfill the needs of the public.

Liaison Program

In order to more closely integrate the YLC with other portions of the Virginia State Bar, especially sections and committees, we decided to create a liaison program. Our liaisons are required to attend section/committee meetings and provide reports to the YLC regarding the section/committee's activities. The liaison will also be responsible for facilitating contact between the two entities if an idea or a request for assistance arises. These liaisons serve ex-officio on these boards and would not be funded to attend meetings, most of which either occur in Richmond or over teleconference.

The YLC opened solicitations online for all our leadership positions this April, including our new liaisons. Candidates were able to submit applications for leadership positions through the YLC website for the first time in the organization's history. Nearly 50 applications were submitted by the deadline in June, giving President-Elect Brian Wesley a strong bench of candidates to choose from for his 2018-2019 leadership team.

New Committees

Our new Public Relations/Social Media committee is now led by Amanda Gregory of Chesapeake and Christina Stierhoff of Virginia Beach. If you have been paying attention to the more clever memes on our facebook, twitter, or Instagram, you can thank them.

The Wellness Initiative is new and chaired by Harrison Powell of Newport News and Tiago Bezerra of Fairfax.

Our Pro Bono Committee is now chaired by Erin Witte of Richmond, Rebecca Eubanks of Fairfax, and Carly Anderson of Fairfax. They are in the midst of putting together Legal Checkups along with Legal Services of Northern Virginia and their Veterans' Initiative. The Pro Bono Committee has been hard at work putting together the Legal Checkups. They have partnered with Legal Services of Northern Virginia's Veterans Pro Bono Initiative. I was able to attend the kick off meeting and was greatly impressed with the dedication of the individuals working on the project. Our chairs have been doing great work, putting together questions that are easy to understand and ask the proper information needed to make a consultation with an attorney potentially easier. We hope to have more shortly.

Finally, Patrick Callahan of Richmond co-chairs the Bench Bar Relations Committee, joining Latosha Ellis of Arlington. They have been studying best practices to recommend to young lawyers who want to put together events with the bench. Additionally, our 7th District Representative, Rachel Horvath, joined up with the Charlottesville Albemarle Bar Association Young Lawyers, to put on a bench-bar social event, which was well attended. Best practices from this event will be put into a guide for young lawyers.

Immigration Outreach Committee – Immigration Consequences of Criminal Convictions CLE

Our Immigration Outreach Committee has become a familiar fixture on our CLE calendar as they convened another program on October 20, 2017. The program sold out and had 50 engaged and active attendees, making the afternoon go faster. Thank you to Sasha Berhsad and Elizabeth Nehrling-Soutirou for putting together the program and Capital Area Immigrants Rights Coalition of Washington, DC for providing our talented speakers and getting materials to us for MCLE approval. Special thank you to HoganLovells for hosting the program at their Tysons Corner office.

Hogar Immigration Clinics

The YLC continues to alert membership to volunteer opportunities with Hogar Immigration Services. The program serves as a one stop shop for those applying for citizenship. Immigrants bring supporting materials (specified on the website) and lay volunteers fill out citizenship forms and materials. Attorneys are needed to do secondary interviews, where the immigrants get a quick legal review to check on red flag issues. Most immigrants clear these reviews but any red flag issues get referred to staff for additional interviews. The YLC brings an average of five to ten additional attorneys to the master list of attorneys per clinic held. Attorneys can be licensed in any state to provide assistance.

Professional Development Conferences

The YLC's CLE seasons was centered around four Professional Development Conferences occurring around Virginia. Each site had six hours of CLE credit with two of those credits being ethics. We held these conferences at the end of September and beginning of October in 2017. Special thank you to Jesse Behringer and Laura Lieberman in Washington, DC, John Morgan and Thai Barker in Tysons Corner, Adam Yost and Nancy Davidson in Richmond, and Rachel Radspinner in Virginia Beach for putting together these conferences, which can be daunting tasks.

FIRST DAY IN PRACTICE SEMINAR

This year's seminar took place on December 5, 2017 at the Greater Richmond Convention Center. A special thank you to our cosponsors, the General Practice Section for their work putting this program together.

Accounting 101 for Lawyers

The YLC's Professional Development held a webinar on September 19, 2017. This course is designed to develop the attendee's knowledge of accounting and provide them with a basic understanding of financial statements and management's discussion and analysis of those statements. The program was designed with legal practitioners in mind to give them the tools to conduct productive conversations and business interactions with accountants and to help them better understand the "accounting language." The program consists of an overview of accounting; an overview of financial statements, including explanations of each type of financial statement; a comparison of audit vs. forensic accounting; and an overview of accounting fraud. Rule of Law Day at the Capitol

On March 29, 2018, approximately 300 middle and high school students from the Richmond, Virginia area participated in this annual program which seeks to provide

students with an enriching, interactive experience about the importance of the rule of law in their daily lives, and to help them better understand the need to preserve and protect it as the foundation for the rights and freedoms we enjoy. The program was a collaborative effort between the Virginia Supreme Court and numerous Bar groups including, the Virginia State Bar's Young Lawyers Section, Litigation Section, and Diversity Conference, the Virginia Law Foundation, the Virginia Bar Association's Rule of Law Project, and the Communities in Schools Program of the Richmond and Henrico Public Schools. Teachers, lawyers, judges, and law enforcement officers partnered to educate and inform students about the rule of law and its importance to our way of life.

The program opened with perspectives on the Rule of Law provided by leaders representing the three branches of government and other special guests. Presenting leaders included the Honorable Cleo E. Powell – Justice of the Supreme Court of Virginia; the Honorable Donald W. Lemons – Chief Justice of the Supreme Court of Virginia; the Honorable Roger Gregory – Judge of the Fourth Circuit Court of Appeals; the Honorable Antoinette V. Irving – Sheriff of the City of Richmond; the Honorable Jennifer McClellan –Virginia State Senator; the Honorable Michael N. Herring – Commonwealth's Attorney for the City of Richmond; Alfred Durham – Chief of Police for the City of Richmond. Following this segment, the students were divided into two groups: high school students participated in an hour long "Rule of Law/Fact Pattern Scenario" discussion facilitated by volunteers, and middle school students traveled across the street for a presentation at the Supreme Court of Virginia. Then the group's switched places and the discussion groups/address were repeated.

The small group discussions are intended to provide a positive opportunity for the students to meet with Virginia lawyers, judges, and law enforcement officers to explore the application of the rule of law in their lives. Volunteers moderated the sessions and assisted in answering specific questions posed by the students about particular areas of the law as well as the volunteers' roles in the legal system.

The planning committee sponsored a contest for students to design and submit a logo for the program, and there is an essay contest for further student participation following the day of the event.

Bench-Bar Dinner

The 2018 Bench-Bar Dinner took place at a downtown Richmond hotel on March 29, 2018, which is a new and larger venue. The keynote address was delivered by the Honorable Mary B. Malveaux of the Court of Appeals of Virginia. Judge Malveaux, who was honored at the 2017 Bench-Bar Dinner following her appointment to the Court of Appeals, was also the first African-American woman to serve full time as a judge for the Henrico County Circuit Court, and is the second African-American woman to sit on Virginia's Court of Appeals. She spoke about the importance of mentorship for a young lawyer and illustrated her message with anecdotes about the mentorship that she received early in her career as a criminal prosecutor and defense attorney. In attendance at the event was the Chief Justice of the Supreme Court of Virginia, other members of the judiciary, members of not-for-profit legal organizations, law schools, law firms, the Office of the Attorney General, and other valued members of the Bar. It was a wonderful evening and the YLC will continue to host this event in the future.

Minority Pre-Law Conference

This year's conference took place on April 7, 2018 at Antonin Scalia Law School at George Mason University (Arlington). Sessions introduced prospective law students, college-aged and above, to the nuts and bolts of getting into law school and thriving in a

future legal career. The Pre-Law Conference covered all aspects of students' entering the legal profession, including law school admissions, LSAT prep, and panel discussions with legal professionals and law students on various related topics. Participants walked away with valuable information to pursue a future career in the law.

Wellness Initiative: The Introverted Lawyer webinar: May 7, 2018. This free wellness webinar was approved for 1.0 hour of MCLE credit. Professor Heidi Brown will discuss the seven steps toward authentically empowered advocacy. The webinar sold out in less than five minutes.

The "Wellness Corner" debuted in the spring edition of Docket Call. Watch for this piece every quarter as part of the YLC's growing presence in the world of wellness.

Admission and Orientation Ceremonies

We continued our tradition of welcoming new lawyers to the bar by putting together ceremonies with the Supreme Court of Virginia to swear in those who passed the bar exam. Both ceremonies were thought out, tasteful, and a memorable experience for the new bar admittees and their families. In addition to YLC President Chris Fortier, VSB President Doris Causey, and representatives from Lawyers Helping Lawyers spoke at the Orientation portion of the ceremony, before the Supreme Court of Virginia convened. The YLC thanks Jennifer Wong, volunteers chair, Jasmine McKinney, sponsors chair, and Annie Cai Larson, program chair, for their hard work, dedication, and attention to detail that these ceremonies need in order to be successful.

Updated Emergency Legal Services Plan: In 1993, the Virginia State Bar (VSB) tasked the Young Lawyers Conference (YLC) with developing and implementing the statewide Emergency Legal Services Response Plan (the Plan), which governs communication plans in the event of natural disasters and other declared emergencies. The Plan outlines how the VSB will provide free legal services to its citizens in the event the President or Governor declares a state of emergency. The last time the YLC made major revisions to the Plan was in 2007. In light of the number of significant natural disasters in the recent years, the Emergency Legal Services (ELS) Committee wanted to ensure VSB and the pro bono volunteers were armed the latest information and resources to best help the Virginia population.

In November 2017, the ELS Committee updated the Plan with significant changes. To improve the usefulness of the Plan, ELS worked on improving the comprehensive nature of the Emergency Legal Services Manual with the latest federal and state laws. With the help of over twenty (20) volunteers across the YLC, the ELS Committee developed twelve topical guides of the most common state legal issues for the manual, ranging from bankruptcy to wills and probate. The manual also includes national and federal aid programs that may be able to assist. Additionally, the ELS Committee revised the chain of command provisions in the Plan to: (1) reflect new provisions of the Commonwealth of Virginia Emergency Operations Plan; and (2) establish the YLC chain of command for legal services following natural disasters. There are future plans to include more topical guides with frequently asked questions (FAQ).

Professional Development Series Webinar: Digital Forensics and eDiscovery. On May 8, 2018, the Professional Development Series held another webinar on the topics less covered by the world of continuing legal education. This course covered the importance of identifying the appropriate data sources, understanding and uncovering digital traces of a crime, and techniques and strategies for litigating cases more effectively and efficiently. This course was approved for 1.5 hours of MCLE credit.

2nd Annual Leaders and Careers in the Law Event. May 12, 2018. In honor of Asian Pacific American Heritage Month, our Children and the Law Committee put on the 2nd Annual Leaders & Careers in the Law day at Fairfax Circuit Court. The event sold out with nearly 70 high school students and parents attending. Judge John Tran was the keynote speaker and students were able to attain information on how to become a lawyer. Law school admissions personnel were on hand to discuss getting into law school and provided information to the attendees about their schools. The following law schools participated: University of Virginia School of Law, William & Mary Law School, American University Washington College of Law, University of Richmond School of Law, Washington & Lee University, and George Mason University Antonin Scalia School of Law.

YLC and JOINT COMMITTEE SHOW HOW TO BECOME A MEDIATOR: The Joint ADR Committee and the VSB Young Lawyers Conference have partnered together to create a mentorship initiative geared toward young lawyers. The project has already put on two training teleconferences: Effective Advocacy in Mediation (with The Honorable Stanley P. Klein (retired), Donita King, and Julie Hottle Day) on May 9, and How to Become a Mediator on June 13.

Thank you to our special guests! This year, the YLC entertained a number of guest speakers to its Board meetings and dinners. At our September Young Lawyer Leader Institute, we welcomed Senator Jennifer McClellan and VSB President Doris Causey. Joining us in November was ABA Young Lawyers Division Chair Dana Hrelic Ciolli. In April, we were enthused to be joined by Virginia Bar Association President (and past YLC President) C. Steuart Thomas and Executive Director of Blue Ridge Legal Services John Whitfield. We also had some of our fellows join us at the dinners during the year.

YLC with the American Bar Association Young Lawyers Division

President Chris Fortier joined Victoria Walker, an ABA YLD scholar this year (and the YLC Women and Minorities in the Profession Chair) as the primary representatives from Virginia to the ABA Young Lawyers Division Assemblies in New York City for the August meeting and in Vancouver, British Columbia, Canada for the February Midyear Meeting. Chris and Victoria were joined by the ABA YLD District Representative for Virginia and Maryland, Edwin Wu, and YLC Governor Melissa Little for these Assemblies. These Assemblies provide delegates with the opportunity to hear from ABA leadership and weigh in on ABA policy proposals and potential model rule changes from a young lawyer's point of view. These voices are then taken for final consideration to the ABA House of Delegates, of which YLC Governor Providence Napoleon serves as Virginia's young lawyer delegate.

The YLC also participated at the Spring Meeting in Louisville, Kentucky where President Chris Fortier, Secretary Farnaz Thompson, and Governors Shemeka Hankins and Craig Ellis participated in events such as the Affiliates Training, where young lawyer leaders from across the country participated in sessions educating them about running a young lawyer organization, and the Affiliates Showcase, where young lawyer organizations show off their best programs. This year, the YLC showcased its Professional Development Series and its Immigration Outreach Committees.

Budget and Finance

Marni E. Byrum, Chair

The Standing Committee on Budget and Finance met on April 19, 2018, to review and approve the staff's proposal for the FY 2019 operating budget. The budget was reviewed and approved by the Executive Committee on June 13, 2018. On June 14, 2018, Bar Council considered, and unanimously passed, an operating budget of \$14.1 million for FY 2019. Chief Justice Lemons communicated the Court's preliminary approval of the budget as submitted on May 23, 2018, to Karen Gould, Executive Director and Chief Operating Officer. The Court will consider the FY 2019 budget during its August 2018 Business Meeting.

The budget reflects a decrease of approximately \$806,000 over the budget for the prior fiscal year which ended on June 30, 2018. The decrease is primarily due to a decrease in the Clients' Protection Fund Assessment from \$25 per active member to \$10 per active member. In addition, salaries are based on 92 FTEs for FY 2019, which reflects a net decrease in two positions from the FY 2018 budget. The budget also includes a 2% bonus for VSB employees effective November 2018. The General Assembly did not approve a 2% bonus for state employees, therefore, anticipated expenditures of the bar will decrease by approximately \$137,730 in salaries and benefits in FY 2019.

The Committee continues to evaluate the appropriate levels of reserves and dues for the Bar.

Standing Committee on Lawyer Discipline

David J. Gogal, Chair

The Standing Committee on Lawyer Discipline oversees the attorney disciplinary process, including the bar's investigation and prosecution of complaints. Members of COLD are assigned to monitor the progress of investigations and prosecutions in each of the district disciplinary committees through interactions and discussions with VSB counsel and committee chairs. In addition, the oversight subcommittee randomly reviews case files to ensure that VSB counsel handled them in a procedurally correct manner. In FY 2018, there were approximately 120 random reviews. Specific files are also reviewed on occasion if complainants or respondents question the handling of a case, and in FY 2018 there were three such reviews.

COLD formulates and presents proposed amendments to Part Six, Section IV, Paragraph 13 of the Rules of the Supreme Court of Virginia, which governs the disciplinary process. Proposed amendments are published for comment and then presented to the Virginia State Bar Council, which decides whether to petition the Supreme Court for adoption of the changes. In FY 2018, proposed revisions to Paragraph 13 included the addition of 13-1.1 to define Burden of Proof, and changing references to CRESPA (Consumer Real Estate Settlement Protection Act) to RESA (Real Estate Settlement Agents) to conform to Chapter 27.2, Title 55, of the Code of Virginia. Both proposed revisions were approved by the Supreme Court of Virginia, effective June 15, 2018.

In addition, COLD approved amendments to Paragraph 13 dealing with the fees and costs of guardians ad litem, retirement of permanently impaired attorneys, and the sharing of information with lawyer assistance programs. These proposals were approved by Council in June 2018, and will be presented to the Supreme Court of Virginia for consideration.

The committee is comprised of ten attorneys, two laypersons, and the first vice chair of the VSB Disciplinary Board, who serves ex officio. In FY 2018, the committee met every other month beginning in July and continuing through May. David J. Gogal, served as chair of COLD, James W. Hundley chaired the rules subcommittee, and Beverly P. Leatherbury, served as vice chair of COLD and chair of the oversight subcommittee.

COLD hosts an annual Disciplinary Conference which is attended by attorney and lay members of the district committees, the Disciplinary Board, COLD members, and judges who sit on three-judge circuit court panels that hear disciplinary matters. The programs at the conference are designed to provide education and updates on the disciplinary process to the volunteers serving in the disciplinary system. The FY 2018 conference was held at Wintergreen Resort on July 27 and 28, 2017. Attendees included 146 members of district committees, the Disciplinary Board and COLD.

Legal Ethics

Eric M. Page, Chair

The Committee received two LEO requests in FY 2018; one resulted in LEO 1889 (pending approval by SCV) and one has been carried over to FY 2019. The Committee also resolved, by informal letter to the requester, one LEO request that was carried over from FY 2017.

The Committee issued three LEOs for review/approval by Council and SCV:

- Revised LEO 1750 Advertising Compendium; approved by the SCV on April 20, 2018, effective immediately
- LEO 1885 Ethical Considerations Regarding a Lawyer's Participation in an Online Attorney-Client Matching Service; approved by VSB Council in October 2017; pending approval by SCV
- LEO 1889 Scope of Representation Duty of Court-Appointed Lawyer to Appeal Termination of Parental Rights Order; approved by VSB Council in June 2018; pending approval by SCV

The Committee released three proposed rule amendments for public comment:

- Proposed Rule 1.10(a) Non-imputation of personal conflicts; issued for public comment in May 2018
- Proposed Rule 1.8(e) Financial assistance to clients; issued for public comment in May 2018
- Rewrite of unauthorized practice of law rules proposed by the Study Committee to Revise the Unauthorized Practice Rules; issued for public comment in May 2018

Opinions pending consideration by the Committee include:

- Prosecutor's duty to disclose evidence favorable to defendant
- Rule 4.2 compendium opinion
- Inadvertent disclosure of privileged information

The Committee also withdrew four LEOs: 1029, 1119, 1297 and 1321.

Ethics hotline calls through June 29, 2018, totaled 7,286, for an average of 607 calls per month.

Professionalism

The Honorable David W. Lannetti, Chair

The Standing Committee on Professionalism is charged with the execution, administration, and ongoing oversight of the mandatory Harry L. Carrico Professionalism Course, which all newly admitted active members of the Virginia State Bar are required to attend. The purpose of the course is to encourage attorneys to uphold and elevate the standards of honor, integrity, and courtesy in the legal profession. Since institution of the program in 1988, over 40,300 new admittees have taken the course—significantly more than the current number of active Virginia licensed lawyers.

The course faculty is comprised of distinguished lawyers and judges representing a broad cross-section of the legal profession in Virginia. Faculty members are nominated by their peers, lawyers, and members of the judiciary. Based on the needs of the course, less than ten percent of the nominees are approved by the Standing Committee on Professionalism and invited by the Chief Justice to accept appointment for a single three-year term.

The course was offered a total of eight times during the 2017-2018 bar year as follows: three times in Northern Virginia; twice in Richmond; and once in Roanoke, Norfolk, and Charlottesville. There were approximately 1,225 attendees at these courses. The Committee noted the decline in attendance compared to previous years and presumes it was due to lower enrollment in law school (which now appears to have subsided, although course attendance necessarily lags law school enrollment). In addition, there was an all-day faculty training event each Fall for both new and returning members.

The Committee was privileged to welcome the Honorable B. Waugh Crigler, the Honorable Douglas E. Miller, the Honorable David J. Novak, the Honorable Rossie D. Alston, Jr., the Honorable William T. Newman, Jr., the Honorable Robert S. Ballou, the Honorable Roderick C. Young, and Joseph A. Condo as luncheon speakers this year. Additionally, the VSB President—Doris Henderson Causey, this year—delivered welcoming remarks to the attendees at each course, for which the Committee is grateful. The participation of judges and

Meetings:

The Committee met in Richmond on 8/29/2017, 1/24/2018, and 4/24/2018 and during the joint Pro Bono Conference/Virginia Legal Aid Conference in Charlottesville on 10/18/2017.

Over the course of the Bar Year, the Access Committee worked on a variety of access to justice issues through its subcommittees: Awards, Pro Bono Training/CLE, Alternative Delivery Systems/SRL, Rules, Legal Aid Funding, Social Media, and Joint Access to

Legal Services/Virginia Lawyer Referral Service (disbanded). During regular Access Committee meetings, subcommittees would report on their work and receive input from the entire Committee. Over the course of the Bar year, the Access Committee and its subcommittees heard about and discussed access to justice issues with numerous guests, including Doris Causey, VSB President; James McCauley, VSB Ethics Counsel; John Whitfield, Co-chair Virginia Access to Justice Commission and Executive Director, Blue Ridge Legal Services; Ellen Bowyer, Staff Attorney to the Access to Justice Commission of the Supreme Court of Virginia; Ray White, Executive Director, Virginia Law Foundation; Caitlin Bradley, PES Staff Attorney, Virginia Sexual and Domestic Violence Action Alliance.

Virginia.freelegalanswers.org:

Virginia.freelegalanswers.org, the online, interactive, pro bono question and answer website hosted by the Virginia State Bar, celebrated its one year anniversary on August 22, 2017. The Committee continued to support the Virginia Free Legal Answers portal through daily administrative functions of the staff liaison and year-round promotional engagements. Additionally, two interactive CLE training events were held at Virginia law schools to train volunteer attorneys and educate law students. Quarterly email updates were sent to volunteer attorneys containing helpful tips, reminders, website statistics, and volunteer recognition to increase engagement and interest. These efforts have resulted in significant growth, as of July 17, 2018, in the number of clients (1301 registered clients), volunteer lawyers (300) and questions asked (1,160) and answered (1,093). Virginia.freelegalanswers.org has consistently had an attorney response rate of 94 to 95 percent, consistently putting us at the top of the nation in this category. An estimated 420 hours of pro bono service have been contributed to date.

Amendments to the Rules Governing Emeritus, Pro Bono Reporting, and Limited Scope Appearance:

Voluntary Pro Bono Reporting

Members of the Access Committee worked closely with members of the Virginia Supreme Court's Access to Justice Commission to draft a voluntary reporting proposal for submission to the Supreme Court of Virginia. On December 21, 2017, the Commission submitted the jointly endorsed proposal to the Court. On February 27, 2018 the Court approved the addition of Paragraph 22 to Part 6, Section IV of the Rules of the Supreme Court of Virginia, which requests that each active Virginia State Bar member voluntarily report their pro bono hours and/or financial contributions in support of pro bono legal services on their annual dues statement. The new voluntary reporting rule goes into effect on December 1, 2018. The July 2019 VSB annual dues statement for the 2020 bar year will be the first to incorporate voluntary pro bono reporting. In response to the rule change, the Access Committee published an interactive FAQ to help members understand the new rule and identify opportunities to contribute to pro bono. The FAQ was distributed to members in VSB news, posted on the Access Committee's Facebook page, printed in the April issue of Virginia Lawyer magazine, and distributed at various bar events and presentations. Additionally, the Access Committee coordinated with the Access to Justice Commission to procure a letter from Chief Justice Lemons reminding members of the new rule and encouraging them to contribute, track and report their pro bono efforts, which was included in the July 2018 dues statement and published in the June issue of Virginia Lawyer magazine. The Committee is involved in ongoing efforts to promote voluntary reporting and leverage the rule change to increase pro bono participation and financial support to legal aid and nonprofit pro bono service providers.

Emeritus Membership

The Access to Legal Service Committee continued work on amendments to the Emeritus rule to facilitate increased pro bono engagement by retiring and retired members of the Bar. Following the close of the public comment period on June 30, 2017, the Access Committee submitted the proposed rule change to the Executive Committee for consideration. On September 14, 2017, the Executive Committee unanimously voted to recommend approval of the amendments to the Emeritus Rule to Bar Council. On October 27, 2017, Bar Council approved the proposed amendments and thereafter the proposal was submitted to the Supreme Court of Virginia for consideration. The Court approved the proposed amendments to the Emeritus Membership Rule by Order dated December 29, 2017 and the new rule went into effect on March 1, 2018. The Access Committee launched a number of robust promotional campaigns in response, including establishing the "Transition Into Emeritus Status" (TIES) program. The Committee created TIES branding and brochures, which was published in the Senior Lawyer's Conference newsletter and in the Virginia Lawyer magazine. In June 2018, brochures were distributed at the 50 Years of Service brunch at the Annual Meeting and mailed to more than 300 previously active members to boost interest and participation in the program by senior lawyers. Additionally, the Committee worked closely with VSB Communications to publish multiple articles highlighting the rule change in Virginia Lawyer and other bar publications. Within the first seven months of the promotional campaign, more than 15 attorneys have contacted the state bar expressing interest in the program. Four new emeritus members have been approved as of July 31, 2018, representing a 300 percent increase in membership following the implementation of the new rule. Additional applications are in process.

Limited Scope Appearance

The Rules Subcommittee of the Access to Legal Services Committee met several times to discuss amendments to Rule 1:5 as proposed by the Advisory Committee on Rules of Court (ACROC) on December 1, 2017 (original proposal) and March 1, 2018 (revised proposal). At its February and June 2018 meetings, the Rules Subcommittee considered additional changes to make the rule more conducive to access to justice and pro bono. Significant progress has been made to date; specifically, ACROC's current proposal reflects many of the changes recommended by individual members of the Rules Subcommittee as reflected in the Access to Justice Commission's comments to ACROC's original proposal, which it submitted on March 1, 2018. The Committee's work in this area is ongoing and is being done by the Rules Subcommittee members in close collaboration with the Access to Justice Commission with the goal of successfully engaging with ACROC and the Court to foster the adoption of an access-friendly rule change.

Free and Low Cost Legal Resources in Virginia Pamphlet:

In February 2017, the Access Committee published, on behalf of the Virginia State Bar, a pamphlet entitled "Free and Low Cost Legal Resources in Virginia". This eight page pamphlet is a guide for helping low-and modest-income Virginians find legal assistance and includes options for assistance by counsel and options for self-represented litigants. The Access Committee completed distribution of more than 30,000 copies to all Virginia legal aid offices and law libraries in the 2018 Bar year. Distribution efforts to court clerks, social services organizations and other venues are ongoing. Conferences, Webinars, Seminars, Presentations, and Outreach:

The 2017 Virginia State Bar Pro Bono Conference was held on October 18, 2017, in Charlottesville in conjunction with the Virginia Legal Aid Conference. This was the fourth time these events were held together, and attendees were welcome to attend sessions at either conference. More than 65 people participated in the conference, plus additional attendees from the Virginia Legal Aid Conference.

The Access Committee collaborated with Legal Aid organizations, law firms, non-profit legal services organizations, and bar associations to offer several webinars and seminars during the 2017-18 Bar year. Attorneys who attended VSB Access Committee sponsored or co-sponsored programs certified that they will either accept a pro bono referral from a legal aid or non-profit pro bono legal services provider or make a financial contribution to one of these organizations. The Access Committee also supported webinars developed by the VSB Young Lawyers Conference and the VSB Intellectual Property Section.

To support the transition into her new role as Director of Access to Legal Services after succeeding Karl Doss in November 2017, Crista Gantz made outreach visits to seven legal aid offices and two nonprofit legal service providers to meet the staff and discuss challenges and opportunities. Additional outreach efforts to the two remaining legal aid organizations and additional nonprofit legal service providers are ongoing.

Awards and Recognition:

On October 18, 2017, during the Pro Bono Conference, the Committee presented the Lewis F. Powell, Jr., Pro Bono Award to Ofelia Calderon. The Committee also presented the inaugural Frankie Muse Freeman Organizational Pro Bono Award to McGuire Woods LLP. Committee Chair Chip Nunley was the master of ceremonies and VSB President Doris Henderson Causey gave the guest remarks. More than 250 people attended this event.

On June 15, 2018, during the Legal Aid Award Luncheon at the VSB Annual Meeting, the Committee presented the Oliver White Hill Law Student Pro Bono Award to Charu Kulkarni of Washington & Lee University School of Law and the Legal Aid Award to Dipti Pidikiti-Smith, Director of Advocacy with Legal Services of Northern Virginia. The Committee also recognized long-time legal aid advocate Kathy Pryor for her more than 30 years of service. Anne Holton provided guest remarks. More than 75 persons attended this event.

The committee focused this year on hearing from speakers on various issues. Paulette Davidson, VSB staff liaison for the Conference of Local & Specialty Bar Associations, provided information at each committee meeting on the status of speakers and topics for the upcoming Solo & Small Firm Forums that were being held on May 4, 2018 in Abingdon and May 10, 2018 in Hampden-Sydney, as well as the development of additional programs.

Pat Davis, Program Director of the Judicial Performance Evaluation Program, gave an update at the January 2018 meeting on the Judicial Performance Evaluation process and answered questions from the committee.

Circuit Court Judge Lowe of Abingdon gave a report on the Abingdon program, which had 140 attendees. Future of Law

Since its inception in late 2014, the VSB Study Committee on the Future of Law Practice – this year having transitioned to a more permanent "special committee" -- has continued to evaluate current developments to assess how these changes will impact the practice of law. The goal of the Committee is to help illuminate the changing landscape of the practice of law, both to help educate lawyers and to help prepare them for a future that is continually changing.

The Committee met in person five times this year. Currently, the report posted on September 15, 2016 (PDF here) is in the process of being updated and will contain additional/updated recommendations, the final of which will also be submitted for public comment this fall.

The Committee continued to engage in the extensive gathering of information, reading everything it could find on the future of law practice – articles, ethics opinions, and studies by other bar associations. Irving M. Blank serves on the committee as a nonvoting member representing the Executive Committee. Karen A. Gould, Executive Director of the VSB, attends the meetings as the committee's liaison. There were former members of the committee who served when others could not, such as Todd G. Patrick of Waynesboro, Crystal Y. Twitty of Sandston, and Ronald R. Wesley of Richmond.

The committee screened and evaluated candidates for three federal vacancies during FY2017-2018, at the request of U.S. Senators Tim Kaine and Mark Warner.

The evaluation process undertaken by the JCEC is time consuming and complex. The JCEC members conduct an investigation of each candidate in advance of the meeting by interviewing lawyers and judges familiar with that individual. The JCEC then receives the reports of each investigation before interviewing each candidate. After the candidates are interviewed, a vote is taken as to whether the candidate is "Qualified," taking into consideration the factors outlined in the JCEC policy, i.e. integrity, professional competence, experience, temperament, civic activities and public service. A majority of the JCEC members voting is required for a candidate to be designated as "Qualified." A majority of those voting in a second vote is required for a candidate to be designated as "Highly Qualified." The "Highly Qualified" designation is an evaluation of "whether any of the candidates deemed qualified possesses a level of qualification and distinction to merit the designation of 'Highly Qualified." If a candidate is found not to be qualified for whatever reason, no report is prepared regarding that candidate.

The findings by the Committee are specific to the vacancy for which the candidates have expressed interest. The Committee's evaluations should not be interpreted as, or considered to be, a determination by the Committee of the qualifications of the candidates to serve on a tribunal other than the United States District Court for the Eastern District of Virginia.

The Committee started each interview with the following series of questions:

Have you ever had a civil judgment entered against you? Have you ever been subject to lien by a government or administrative agency? Have you ever been sanctioned by a government, administrative or regulatory agency? Have you ever been subject to a collection action for failure to satisfy a judgment, lien, or other sanction? Do you have any tax issues that you think this Committee should know about?

Lawyer Insurance

David D. Hudgins, Chair

ALPS Property & Casualty Insurance Company is the VSB's endorsed professional liability insurance carrier. The Special Committee on Lawyer Insurance (LIC) continued its overview of ALPS's risk management endeavors and, for the first time, started its oversight of the VSB Members' Insurance Center's efforts to help VSB lawyers obtain and manage personal (health, life and disability) insurance.

The LIC met 4 times in FY2018:

VSB Members' Insurance Center

The VSB Members' Insurance Center, led by Bob Spicknall, continues to enroll small law firms, often with only one employee, in health insurance. Since the fall of 2018, it established approximately 120 new groups totaling 226 insureds. These people now benefit from group health insurance that costs far less than individual health insurance. Bob reported in late April of 2018 that Virginia Senate Bill No. 672 had passed, which revises the definition of "small employer" for purposes of health insurance to include a self-employed person, effective July 1, 2018. It is most likely that solo practitioners of all industries, who work 30 hours per week, will become eligible for group health insurance sometime this summer. Bob cannot overstate the significance of this new law. The VSB sole practitioner, or group of one, "association" ability was removed by the ACA in 2014. Effective January 1, 2018 individual coverage became 30-35% more expensive than group coverage. Many VSB members who do not employ anyone grew frustrated because they could not establish group coverage and had to settle for expensive individual coverage with limited options and limited provider networks. Bob says it is now likely that these VSB sole practitioners will be eligible for group health insurance this summer.

ALPS and Lawyer Malpractice Insurance

ALPS operates on a calendar-year basis. As of December 31, 2017, There were 1,912 Virginia firms insured by ALPS, out of a total of 7,041 firms, and 3,943 lawyers, out of a total of 15,970 lawyers insured by ALPS. Gross written premium written in Virginia was

\$9,831,565; net written premium was \$6,606,641. Net combined ratio in Virginia as of 12/31/2017 was 119.42%; claims frequency was 3.67 in Virginia. Net combined ratio for ALPS overall was 99.91% as of 12/31/2017 with a claims frequency of 3.66%.

On-Demand Programing

Currently, 15 programs exist in the Virginia on-demand library. They range in length from 45min to three hours. New on-demand programs have been added throughout the year. Charges for the on-demand seminars are as follows: programs for one hour \$35 for insureds, \$65 for non-insureds; two hour programs \$45 for insured, \$75 for non-insured; and three-hour programs \$60 for insureds, and \$90 for non-insured. Quarterly Result: In Q1 of 2018, ALPS had 90 VA registrants for on-demand programs, with 70 ALPS insureds and 20 non-insured.

Webinar Programming: In Q1 ALPS did two webinars.

On February 28, 2018, ALPS presented How to Avoid Conflict of Interest Malpractice Missteps. This program was presented by Mark Bassingthwaite. They had 34 registrants, with 32 insureds and 2 non-insured.

On March 22, 2018, ALPS did its first New Lawyer webinar of the year, The Devil Wears Green: Trust Accounting Basics for New Lawyers. This was presented by Jeannie Dahnk of Glover and Dahnk. There were 30 registrants, with 11 insureds and 19 non-insured.

Quarterly Result: In Q1, ALPS had 64 VA registrants for Webinars, with 43 ALPS insureds and 19 non-insured.

YTD Result: YTD, they had 64 VA registrants for Webinars, with 43 ALPS insureds and 19 non-insured.

Lawyer Referral

Jack L. Harris, Chair

The Virginia Lawyer Referral Service (VLRS), 'Celebrating 40 Years' of public service has received 12,675 calls from persons in need of assistance with possible legal matters in Virginia. Of those calls, the VLRS has provided 3,963 prescreened and prepaid referrals to its active panel members; resulting in \$172,060.00 non-profited revenue for the bar.

The Virginia State Bar (VSB) Special Committee on Lawyer Referral commends the 351 VLRS attorney panel members for their (past and present) service to the bar and their communities. The VLRS welcomed 65 first-time panel members. The Committee's focus was to bring awareness of the VLRS to VSB members by promoting the value of its panel membership; and to the General Public by enhancing consumer protection when referring to private lawyers to ensure their legal needs were being met. Those goals were met by:

- 1. American Bar Association (ABA) Program of Assistance and Review (PAR) of the VLRS on October 18, 2017. The PAR review suggested the Committee make specified changes to the service for its continuing public service and panel membership support.
- 2. Rule revisions for the VLRS.
- 3. Strategic Plan created and implemented; along with establishing common goals with the VSB Access to Legal Services (Modest Means) and the Conference of Local and Specialty Bar Associations (CLSBA) to better fulfill the mission of the Bar. Committee members Jack Harris and Sarah Morton met with the Legal Aid Project Directors in Charlottesville on March 19, 2018 (in a joint effort) to better understand the services that each program provides to the citizens of Virginia.
- 4. Consumer and Panel Member surveys created and sent bi-monthly and every six-month (respectively) receiving valued feedback on the consumer and business services provided by the VLRS.
- 5. Referral Requests by email implemented August 20, 2017. VLRS has received 322 referral requests and has answered and responded to those referral requests (within 48 business hours) by reply emails and/or calls.
- 6. Online Pre-paid Referral System launched on March 19, 2018 to general public for 24/7 self-referrals. The Online Prepaid Referral System has been utilized by 109 consumers.
- 7. On-Site Panel Membership Promotions: VSB TechShow in Richmond; Solo and Small-Firm Practitioner Forums in Big Stone Gap, Kilmarnock & Hampton-Sydney; the

VSB Young Lawyer Conference (YLC) Admission & Orientation Ceremony in Richmond; and the VSB Annual Meeting in Virginia Beach.

- 8. Featured article in the VSB Virginia Lawyer Magazine June 2018 "VLRS: We are Looking for the Next C. Butler Barrett"; and VSB News and Information articles to promote the new Online Referral System, the Referral Requests by Email, and ongoing panel membership recruitment of VSB members in underserved referring areas of Virginia. Article for the Conference of Local and Specialty Bar Associations (CLSBA) *The Connection Newsletter*(Summer 2017) "The Virginia Lawyer Referral Service: Helping Others While Helping Your Practice" written by Special Committee on Lawyer Referral member D. David Parr, Jr.
- 9. New panel membership application (with expanded areas of law practices) that required more detailed law office information to enhance the referral screening process for better consumer-to-lawyer matching. New informational consumer Bookmarks developed in May 2018 for statewide distribution.
- 10. Changes to the Virginia Lawyer Referral Service website to make it more consumers friendly and the panel membership information more visually appealing to its readers.
- 11. Assistance provided to the: VSB YLC Emergency Legal Service (ELS) responses to natural disaster Hurricanes Harvey & Irma; the Greater Richmond Bar Foundation (GRBA) & Virginia Bar Association (VBA) Veterans Initiative Program to provide legal referrals to persons affect by the hurricanes and Virginia veterans in needs of legal advice & services.

Resolution of Fee Disputes

Kathryn N. Byler, Chair

The Virginia State Bar resolution of fee dispute program (RFD) was created as a voluntary program to help attorneys and clients resolve disputes over fees and costs paid, charged, or claimed for legal services provided by a member of the Virginia State Bar (VSB) through mediation or arbitration. Our program volunteers include 11 circuit chairs, 160 arbitrators and 48 mediators.

The RFD program benefits VSB members and the public by reducing needless litigation, spurious bar complaints, and Clients' Protection Fund petitions.

The following efforts were made in FY17-18 to promote and encourage use of the RFD program:

- On October 13, 2017, committee members Kathryn Byler, Mary Lynn Tate and Alan Anderson, along with Ethics Counsel Jim McCauley, presented a one hour CLE at the Solo and Small-Firm Practitioner Forum in Big Stone Gap, Virginia. The program was well-received by the approximately 85 attendees.
- The RFD program administrator hosted a webinar training on October 24, 2017, for the circuit chairs. The webinar included review of the program rules followed by open discussion among the chairs of issues that arise during oversight of a case.
- On March 9, 2018, committee chair Kathryn Byler and committee member/circuit chair Edward Whitlock presented a one-half hour CLE at the Bar Leaders Institute. The presentation generated program interest among the bar leaders in attendance, and resulted in a request for RFD CLE to be presented at the Norfolk-Portsmouth Bar Association later this year.
- The June issue of *Virginia Lawyer* ran a featured article on the RFD program entitled "Let's Talk about the Elephant in the Room."
- We continue to run RFD "ads" in Virginia Lawyer and in other VSB section and conference publications/newsletters when possible.
- Circuit committee 17 was reestablished and combined with circuit committee 18. Alan Anderson serves as the chair of this combined circuit committee.
- Circuits 9 and 15 were combined to establish a new circuit committee 9/15. Committee member Robert Stenzhorn agreed to chair this newlyestablished circuit committee.

Of those 221 requests:

- Petitioners returned 103 agreements to circuit chairs for processing (86 from clients, 17 from attorneys);
- 45 of those agreements were accepted by the respondent;
- 24 attorney respondents declined to participate;
- 13 cases were settled prior to mediation or arbitration; and
- 34 cases went to FRD: 28 cases are complete (15 mediations and 13 arbitrations) and 6 are pending (5 mediations and 1 arbitration).

Geographical breakdown of requests:

- 16% were for attorneys practicing in eastern Virginia (circuits 2, 3/4);
- 51% were for attorneys practicing in NOVA (circuits 16, 17/18, 19, 31);
- 23% were for attorneys practicing in central Virginia (circuits 9/15, 12/13/14); and
- 10% were for attorneys practicing in south/southwestern Virginia (circuits 10, 23, 24, 28).

The committee continues to seek ways to encourage member participation and to publicize and promote the RFD at VSB-related events.

Clients' Protection Fund Board

The Clients' Protection Fund was established in 1976 to make monetary awards to people who have suffered financial losses because of the dishonest conduct of Virginia lawyers. The fund is managed by a fourteen-member board appointed by the Virginia State Bar Council. Board members investigate all petitions from clients for payments from the fund. The board hears each petition and determines the amount of loss.

As of July 1, 2017, twenty-three (23) claims were pending from the previous year. In FY 2018, fifty-three (53) new petitions were received. The total amount paid during 2017-2018 was \$103,130.58 representing twenty-seven (27) claims. The board denied fifteen (15) petitions, and eleven (11) petitions were rejected for not meeting the CPF rule requirements. As of June 30, 2018, there were twenty-three (23) pending claims. The board reviewed and investigated fifty-three (53) claims during the year.

The fund began the fiscal year on July 1, 2017, with a cash balance of \$8,911,684. The Clients' Protection Fund \$25 assessment from all active attorneys totaled \$813,060. Interest income, net of bank service charges for the fiscal year, totaled \$138,161. The fund received restitutions from attorney general's collections, debt set-off, and individual restitutions in the amount of \$10,357 net of attorney's fees for collection services. As of June 30, 2018, the cash balance in the fund was \$9,765,666.

The board is to be commended for the many hours spent investigating and deliberating claims, and for the work of its various committees including the public awareness and strategic planning committees.

By Order entered September 28, 2017, and effective July 1, 2018, the Supreme Court of Virginia reduced the amount of the assessment paid by bar members from \$25 to \$10. In addition, effective July 1, 2018, the General Assembly extended the sunset provision of Va. Code Section 54.1-3913.1, which authorizes the statutory assessment for the fund, from July 1, 2020 to July 1, 2023.

Appreciation is extended to Senator Richard Stuart who sponsored the CPF bill (SB 210). Finally, appreciation is extended to retiring board members Nancy Marie Reed and David R. Ruby after their years of service on the board.

The board welcomes Melissa Walker Robinson from the eighth disciplinary district and Charles Franklin Hilton as new members for fiscal year 2018-2019.

Mandatory Continuing Legal Education

The Mandatory Continuing Legal Education (MCLE) Board administers the program that was established by the Supreme Court of Virginia in 1985. The rules governing the MCLE program were amended in 1990 to require all active members of the Virginia State Bar to complete a minimum of twelve hours of approved continuing legal education courses, including two hours of ethics or professionalism, each fiscal year.

The MCLE Board consists of twelve members appointed by the Virginia Supreme Court. In addition to the chair, members for fiscal year 2018 included, Christine L. Poarch of Salem, Vice Chair, Mark S. Brennan of Richmond, Darius K. A. Davenport, Sr. of Suffolk, Lori Beth Galbraith of Chesapeake, Leonard C. Heath, Jr. of Newport News, Zachary A. Kitts of Fairfax, Victoria N. Pearson of Richmond, Kimberly A. Pierro of Mechanicsville, Liza S. Simmons of Richmond, Joanna L. Suyes of Richmond and Tameeka M. Williams of Norfolk.

The Board meets seven times per year at the VSB's Richmond office to, among other things, consider course-approval applications, requests for extensions and waivers, and other matters integrally related to the MCLE process in Virginia. The VSB's MCLE department provides daily administration of the MCLE requirements for the Board. Over the last reporting cycle, the MCLE staff and Board considered the following: 21,188 course approvals, 46 waiver and extension requests and approximately 164,963 certifications of attendance. Usage by attorneys of the online MCLE certification feature continues to increase and enables attorneys to post most of their certifications of attendance directly to MCLE record and view current MCLE record 24/7, saving time, money and effort for both our members and the MCLE department. For the 2017 MCLE compliance year over 77% of the course attendance was certified by the members online. Three hundred three (303) members have taken advantage of the iPhone app for connecting to the member login portal, an increase of 31% over the previous reporting period.

Over the last reporting cycle, the Board continued to study the topics of diversity and bias in the legal profession to determine (1) if alternative approval standards are warranted and, if so, (2) what modifications should be recommended. The Board approved amendments to Opinion 16 to allow for new gaming formats in distance learning programs and Opinion 14 to clarify the standards required for written, instructional materials. The Board also approved and published for comment amendments to Opinion 19 to respond appropriately to the ABA's lawyer wellness report co-authored by Chief Justice Lemons.

At the beginning of this year we welcomed new members, Mark S. Brennan, Joanna L. Suyes and Tameeka M. Williams to the Board. Darius Davenport resigned in March and was replaced by Michael D. Pierce of Norfolk. At the close of the year, three of our members completed their service on the Board: Leonard C. Heath, Jr., former chair and

now 2018-19 VSB President, Liza S. Simmons, and the 2017-18 chair, George William Watkins. With the possible exception of the latter, the Board will miss their insight and dedication to the profession. As this year closes, I want to thank Christine Poarch for her terrific and enthusiastic support as Vice-Chair and her willingness to step up as Board Chair for 2018-19 and, most especially, Gale M Cartwright, our Director of Member Compliance, who will retire at year's end after more than twenty years of service to the MCLE Board. Gale's organizational skills, good humor, wisdom and quiet grace were invaluable to me as I learned the ropes of leadership of the Board this past year.

Although Gale's presence and guiding hand will be sorely missed next year, the MCLE staff will continue to ensure that the MCLE process runs smoothly for both the MCLE Board and the membership of the Virginia State Bar under its new Director, Demetrios Melis. The staff conscientiously provides institutional memory for the MCLE Board, even as members of the MCLE Board come and go over time and their recommendations are solicited and carefully weighed by the Board before every decision is made. The staff richly deserves our thanks for their good work throughout this year. Finally, the MCLE Board is grateful for the assistance of the Executive Director of the Virginia State Bar, Karen Gould, who faithfully attended our meetings and provided valuable guidance to the Board in its deliberations.
